2. SEVERAL (83) CASES HAVE WITHDRAWN THEIR REQUEST FOR VISAS WHEN INFORMED THAT INQUIRY PROCESS COULD TAKE 6 MONTHS OR MORE. SINCE MOST APPLICANTS HAVE SPECIFIC TRAVEL PLANS FOR POINT IN TIME EARLIER THAN 6 MONTHS, THEY CANCEL EVERYTHING AND ABANDON PLANS FOR TRAVEL TO U.S.

3. A SMALL RELATED PROBLEM: POST HAS NOTED THAT AFTER DEPARTMENT SENDS A VISA ONE CABLE IN WHICH IT SPECIFICALLY STATES THAT NAME WILL BE REMOVED FROM AVLOS THAT NAME IS NOT BEING REMOVED. AFTER SEVERAL MONTHS POST THEN HAS HAD TO SEND SEPARATE CLOK CABLE REQUESTING REMOVAL. RATTRAY
