KIBODA's written report of investigation on Subject has just been received, and a review of its contents reveals that the first sentence of reference para 2 is partially inaccurate in that GRACID headquarters overruled the recommendation of its Field Officer in the matter of a visa for Subject.</p> <p>2. It now appears the responsible GRACID Field Officer recommended in June 1957 that Subject be found inadmissible to PERDIE on the basis of his background and his failure to disclose a number of material facts connected therewith. The Officer concluded that Subject represented a security risk to PERDIE.</p> <p>3. GRACID headquarters replied on 2 December 1957 that their files disclosed no derogatory information regarding the applicant that was not already available to the field office. The memorandum also advised that a PERDIE military officer who had been in the Shanghai area during the post-war period and had participated in both the examination of Subject and the preparation of his case for prosecution reported Subject as having been then cooperative and informative. In a final overall analysis, GRACID headquarters did not concur with the Field determination that Subject was ineligible for a visa. As a result, the Dusseldorf office advised its Headquarters by memorandum dated 12 December 1957 that Subject was issued on that date a non-immigrant visa valid for multiple entries for a four year period. However, as reported in reference, appropriate checks have failed to reveal any record of Subject's admission to PERDIE.</p>
