Approval of Minutes

1. Action: The minutes of the meeting of 29 November 1951 (IAC-M-52) were approved.

2. Action: After considerable discussion of the several points on which the IAC representatives needed guidance, the estimate was returned to them with instructions to produce a clean draft which the IAC could consider the following morning.

3. Action: This paper was tentatively approved subject to receipt of the necessary authority from the NSC permitting dissemination of national intelligence to foreign governments. CIA will propose a revision of (NSCID No. 1) for this purpose. Accordingly, it was agreed that action would be deferred with respect to release to NATO of the IAC List of Indicators and NIE-33, "Soviet Control of the European Satellites and Their Contribution to Soviet Power," (see IAC-D-33/3 and IAC-D-39/2).
