THE GENERAL ISSUE OF DISAPPEARANCES FADE AWAY AFTER APPROXIMATELY [redacted] 3.3(b)(1) SIX MONTHS. IN THIS WAY, [redacted] THE GOVERNMENT HOPES TO REMOVE THE CONCERN OF JUNIOR AND MIDDLE-LEVEL OFFICERS ABOUT THE MANNER IN WHICH INVESTIGATIONS OF DISAPPEARANCES WILL AFFECT THE ARMED FORCES.

[redacted] CARLOS ((ALCONADA)) ARAMBURU, MINISTER OF EDUCATION AND JUSTICE, AND LEFTIST MEMBERS OF THE GOVERNMENT AND OF THE GOVERNING RADICAL CIVIC UNION (UCR), HAVE BROUGHT PRESSURE ON ALFONSIN NOT TO CARRY THROUGH WITH THE COMMISSION ALONG THE LINES OF WHICH BORRAS AND ARGUINDEGUI CONCEIVED IT.

AS OF MID-DECEMBER, PRESIDENT ALFONSIN WANTED THE CIVILIAN COURT SYSTEM TO CARRY OUT A SLOWER AND MORE ORDERLY JUDICIAL PROCESS THAN SOME JUDGES INDICATED THEY INTENDED IN REGARD TO CHARGES AGAINST ARMED FORCES PERSONNEL ACCUSED OF EXCESSES DURING THE COUNTERSUBVERSIVE CAMPAIGN. ADDITIONALLY, HE DID NOT WANT TO SEE THE LEGAL PROCESS TURN INTO A WITCH HUNT. THE PRESIDENT INTENDED TO TRY TO SLOW DOWN SOME CIVILIAN JUDGES WHOM HE BELIEVED WERE PROCEEDING TOO FAST IN DISAPPEARANCE CASES. ALSO, HE DID NOT HAVE IN MIND AT THE TIME ANY SPECIFIC ACTIONS AGAINST FORMER PRESIDENT AND RETIRED ARMY GENERAL REYNALDO ((BIGNONE)).
