Prisoner was attached to the Police Litache MINZER for ada, but received his orders from KC SPLIN (LAISBURN). These orders were to provide the cover for the Erkundungs-stab GDRLLTLRM, for which he lived in LAGROTRIB until Lag 41.

On orders from WINZER, Prisonor returned to DERLIM to his old Referat SPAIN E 6. Working under SCHITZ in E 6.

Prisoner remained in VI B 4 but in 1944 was sammarked for special duties in SPAIN. Attended

Transferred from ant VI to have ant as Beg Co Insp to give better canouflage to his Spanish mission. Prisoner was due to leave in Dec 44, but delay in delivery of the microphotography apparatus delayed his departure. It had not yet been delivered show he left by air for SPAIN on 14 Jan 45.

Travelled as how int courier on a diplomatic passport. Prisoner states that a further reason for his mission was that Krim Kon Heins SINGER (representative of int VI in SPLIN) was expecting to be deported and Prisoner was to be SINGER's substitute and to take over his IS org should this happen. In last, SINGER was not on the repatriation lists.

Prisoner was supposed to train numbers of the Police Attaches depts from LISEN and MADRID, and from Hachrichtenableilung MOSIS in micro-liet/graphy, but this did not take place because the apparatus never arrived from BERLIN. His second detail, the extension of the WT net, also met with difficulties. A WT expert ARGES was assigned to him and arrived in SPAIN in Har 45, but before the Embassy closed, only one of the six projected connections was working. Prisoner's third detail, the formation of an IS network, was undertaken too late to be successful. His orders were to rely in the first place on the LRCEICM, network controlled by IS HELINO, a Spanish police official. He most Tallelino three times in all.

Through the latter, Prisoner also not Lt Col VILLIA and was intro-luced by him to José HERMENTIA, living at Commit Welm 97, MURID, a spilotter in the "Direction Conoral de Seguridad". Through TAPIA, Prisoner net inita SiliNAS, Celle Carola de

Parades 78, who became his mistress. Prisoner want on boliday to CORCUBION (Prov of LL COMMA). He made up his mind to settle in CORMINION and became friendly with the layer (PLIMO?), the personnel manager of the Patrion

de Carburantes at CE:, through whom he discovered the existence of the Slack market trade in rubber. This consisted in buying the raw rubber collected by the fisherman and re-selling it at 100% profit

in HUDRID.

Imvelled via L. CORUNA to GIJON; in LA CORUNA he came into contact with the police, his residential pends having expered. He telephoned to TAPIL. Who so arranged matters that he was allowed to continue his journey. In CIJON, he loamed that HIXABUSCHNER, MONTERO and TERMOSTILL were planning a haulage business, and had approached LiPL. for the lean of capital. had refused, whereupon ALMBUSCHUR approached Prisoner. He also refused and pave as excuse that he was already in business with TaPla, which ms untruo; this may be the foundation for the suggestion that he and EPIA were in association. Prisoner, claiming to be unaware that the proposed rubber venture was illegal, attempted to obtain a "Guin" from the Ministry of Trade, but in this he was unsuccessful, and the scheme fall through. Meanwhile, his association with inita MIIN'S progressed apace, with the result that by Dec 45 he had only 20,000 Pesstas left. As had maintained the fiction to inite that he was in business and well-to-do, and now intended to break off relations with her and *reform". He thurefore disappeared to SEVILLE. staying at the Hotel Cristina.

On his return to MDRID from GIJON, he had taken a post with José HERIOSIDE in the "Industria Uniter, Midrid. Ericsiti, also promised him work in ERENTIN.

The letter from 200 dated 15 thr 46 states that in Dec/Jon 46 Prisoner was in possession of 500,000 Peactes. This is dunied in toto by Prisoner. 7. Porsonal Funds

On the closing of the Embassy, Prisoner was in possussion of approx 70,000 Posetas, compitain; his own savings of 20,000 Posetas and his six months' salary amounting to approx 50,000 Posetas. This money was deposited in INTL's safe for custody. Prisoner denies ever receiving money in addition to this, other than smell sure gained by selling his onnorm for 7,000 Posities, and making 2,000 Poseties profit on a tyre transaction.

Distragal

Prisoner asserts that he lived solely on this capital up to his arrest, with the result that by Fob 46 he only had some 20,000 Pesutus last. paid also for the unkup of inita SillNis, and appears to have been completely irresponsible in the handling of his money at this time. his arrest, he bought some yell articles, and gave the remainder of his memory, amounting to some 6,000 Ptas to LONTERO. Prisoner asserts that Miff. received no maney from him whatever. Prisoner gave him a sperting gun and other equipment, but denies any knowledge of a lorry. There was a business transaction of a minor nature by which Prisoner sold ton tyrus to TIPIL for 14,000 Ptas. These were for a larry owned by the latter, but otherwise there is no support for the suggestion in the letter of 4 Jun that TEPIA's share in this "thioves' picuic" was a lorry.

9. Intonio EPI

Prisonor's knowledge of TETA's activities goes back to 1944, though he did not meet him pursually until 1945. Prisoner first heard the name when he was working in Referat VI B 4 (SPLIN) in DERLIN; in mid 44 the Referrt was concerned with the threatened expulsion of German officials from SP.IN, and about this time a report was received from the Police Attache in MIDRID stating that all his assistants together with SINGER (Abt VI representative) were to be deported. He quoted as authority a "reliable source" in the Spanish Pereign Einestry. Prisoner enquired into the identity of this a unablant discovered that it was Antonio TAPIA of the Fereign Ministry, who he i given the info in convernation to Karl SCHWIRZ von HERGE (O March STRIKES O HERGENSCHWER), WINZER's chief agent. THPLE was also on the riles of Lat VI as an occasional informat on matters dealing with Spenish of loial ersonnel.

SCHMEN von LEMME was logarted from SPAIN in Doc 44, and was taken on the strongth of ant VI in LEMMEN. As Prisoner was on the point of leaving for SPAIN, he limited with von LEMME with a view to discovering his contacts. As any those was TAPIN, with whom you makes said he was very friendly, and from whom he had received much infa. The relationship had been passenal, not official, and TAPIN had had no controlling offr or payment, but he havely been given such presents from time to time. You makes advised Prisoner to continue the same methods one to the simply to recruit TAPIN as a paid agent, which would meet with refusal, but to pursue the friendship and endow ur to obtain introductions to other numbers of the Poreign Limitary who would be in better positions to find out high policy than was TAPIN.

In fact, Von JERES returned to SPLIN under the mane of HICHESCHER with Prisoner, and work I there in the dept of the Police Attachs, controlled by Police Inspektor VEVE ACCESSINE had to go very carefully on his return, and the only for it contact which he recoved was TEPI, to when he introduced Prisoner. There was some jealousy between Thris and advised as to the division of Prisoner's assets when he was arrested, MONTARD being under the impression that Prisoner was in passession of much larger assets than was actually the case.
