4. REPORT OF FACTS

On 30 October 1953, substantially the following information was submitted by Informant 3795, who in turn obtained the information from Informant 3052. Informant reported that SUBJECT is closely associated with one Dr. Hugo Kittel, residing at Glasenbach 19, Land Salzburg, Austria. Dr. Hugo Kittel is a relative of Alfred Kittel residing at Stöckerstrasse 30a, Vienna XII, (US Sector). Alfred Kittel is the editor of the Interreport Oet, a magazine which publishes reports on economic and political activities behind the Iron Curtain. The publisher of the Interreport Oet is Peter Rindl, residing at Lechtnerstrasse 3, Vienna XI, (US Sector). Other contributors to the magazine are one Armand Fellner, Theodor Durang alias Ilion, and Baron Wallerstorff, operator of a book import firm at Waagplatz 4/II, Salzburg, Land Salzburg, Austria. Informant reported further that another editor of the Interreport Oet was one Dr. Herbert Koenig. Koenig was apprehended and held by the Soviets in Austria, Land Lower Austria, in May 1953, while traveling from Vienna to Salzburg. Koenig usually carried information about Eastern countries on his person, which he was given by Alfred Kittel in Vienna, to be submitted to Dr. Hugo Kittel in Salzburg-Glasenbach. Upon Koenig's arrest, Dr. Kittel and SUBJECT allegedly intervened on Koenig's behalf with a Major Motechaln, first name unknown, who is assigned to the Soviet Information Service. A few days later Koenig was released and joined SUBJECT and Dr. Hugo Kittel in Salzburg. Koenig has since resigned from the Interreport Oet, whose main offices are located at Turkenstrasse 9, Vienna II (US Sector). (C-0-3)
