

Informent claims IVAN SHAISHVILI is an EKVD agent and that he is head of the Georgian Delegation at G-MICHONS Geneva, Switzerland, through which NKVD agents are sent to various parts of the world. Imformant claims that MIKHARL KADIJ is the chief organisational director of all Soviet civilian espionage in Europe & that his Soviet principal is IVAN SHAISHVILL. Informent stated that MIKHALL KADIJ is the Soviet principal of L. ENGELCHAUPT who informent claims is the director of Soviet intelligence activities in Munich & Heaburg, Germany, According to the informant MIKHALL KADIJ is also the soviet principal of MICHAEL ALSHIBATIA

who, according to the informant, is a source of information for U.S. Army Counter-Intelligence Corps in Munich,

Confidential Informant T-1, of unknown reliability, who claims to have been the Director of a self-established "intelligence unit" in Lurope from 1943 to 1951 advised in October and November, 1951 that a Soviet intelligence apparatus is currently operating in Geneva, Switzerland, and Hamburg, Germany, and that the following persons, whom he claims to be NKVD agents (Soviet Secret Police) are members of that Soviet apparatus:

IVAN SHAISHVILL

T-1 stated that the headquarters of the International Red Cross are located in Geneva, Switzerland. The informant claims that the Soviet Union does not belong to the International Red Cross but that the Republic of Georgia, Russia, does have a delegation there. The informant said that this Georgiam Delegation at Geneva, Switzerland, is in charge of one IVAN SHAISHVILI, an HKVD agent. The informant claims that this Georgiam Delegation is financed by the Red Cross of the Soviet Union and that through the efforts of IVAN SHAISHVILI the Georgian Delegation is being used as a front to send Soviet agents throughout the world.

T-l stated that when the HKVD desires to send an RKVD civilian agent to a country outside of Europe, they send that individual to IVAR SHAISHVILL in Geneva, Switzerland, who in turn obtains an identification card for that individual from the International Red Cross. The informant said that after the identification card is obtained from the International Red Corss the NKVD agent is then able to obtain a passport and proceed to his country of assignment.

The informent stated that NKVD agents which pass through Cenewa, Switzerland, and obtain identification cards from the International Red Cross are primarily engaged in obtaining military information for the Seviet Union throughout the world.

The informant advised that he had never seen IVAN SHAISHVILL and therefore was unable to furnish any further information commercing SHAISHVILL. The informant further advised that IVAK SHAISHVILL is the Soviet principal of one MIKHALL KADIJ, who also - according to the informant - is an MKVD agent.

MIRHABL KADIJ

T-l advised that MIKHAL TARIJ resides in Geneva, Switzerland (address unknown) and that KADIJ is the chief organizational director of all Soviet civilian espionage in Europe. The informant said that MIKHAFL KADIJ, during World War II, worked for one E. ENGELCHAUPT, a member of the German Gestapo in Germany. The informant stated that he had heard that KADIJ, at the time he was working for the German Gestapo, was in reality working as an agent for the Soviets.

T-1 stated that MIKHAEL KADIJ is the Soviet superior of one MICHAML ALSHIBAUA and E. MGELCHAUPT. The informant stated that E. NGELCHAUPT is currently residing in Geneva, Switzerland, and that MIKHAEL ALSHIBAUA is currently residing in Munich, Germany.

Confidential Informant T-1 furnished the following description of MIKRAEL K/DIJ:

E. LNGLLCHAUPT

T-l advised that E. MGr.CHAUTT resides in. Geneva, Switzerland, and is the director of Soviet intelligence activities in Funich and Hamburg, Germany. The informant said that during World Mar II L. ENGTICHAUPT worked for the German Gestapo in Germany and that a MIKHALL KADIJ also worked for the German Gestapo during that period under E. TIGELCHAUPT.

The informant stated that boviet agents working directly for L. ANILCHAUPT are not sent to him by the MKVD but that ENGLICHAUPT selects his own personnel whose background and reliability are subsequently checked by the MKVD. The informant advised that he has not seen R. ENGLICHAUPT and was unable to furnish any information on PROFICHAUPT.

MICHAEL TALBHIBAUA

T-l further advised that MICHAFL ALSHIBAVA in 1944 was working for HIKHAFL KADIJ when KADIJ was working for the German Gestapo in Germany. The informant said that he had heard MIKHAFL KADIJ at the time he was working for the German Gestapo during World War II in reality was working as an agent for the Soviets. The informant said MICHAFL ALSHIBAVA is currently residing in Munich, Germany, and is on the payroll of the United States Army Counter-Intelligence Corps as an undercover agent.

The informant said that in reality MICHAEL ALSHIBAUA is a Soviet agent and that his Soviet principal is MIKHAEL KADIJ in Geneva, Switzerland. The informant said that the Counter-Intelligence Corps has set up MICHAIL ALSHIBAUA with a cover company known as the "Auto Transfor Company" in Munich, Germany, and that ALSHIBAUA is currently on the payroll of the Counter-Intelligence Corps as a source of information.

The informant said that .: LINGL ALSHIBAVA has a brother-in-law who is a doctor and who arrived in the United States

about one year ago. The in orn at believes that MICRAEL ALSHIBAVA's brother-in-law's name is _____ MAGALASCHIVILI.

T-l further edvised that "ICHA L ALSHIBAVA, tegether with about 30 other persons were accused and brought to trial at Berlin, Germany, in 1945 for collaboration with the German Gestapr durin. World War II. The informent claims that MICHALL ALSHIBAVA and the other persons who were brought to trial were defended by an attorney named MICHIL VURARIN, who, according to the informent, is a Soviet agent who now resides in Bern, Switzerland.

Mrs. S.MON LRISTOFF, Engineer, Quinn Engineering Company, 50 Fatts Street, New York City, President of the Caucasian Society, Alleverdy, Inc., New York City and member of the Coorgian Association in the United States advised on May 7, 1951, that one MICHALL ALSHIBAYA was a member of the Georgian Association in Poland. ERISTOFF said that to his knowledge HICHAFL ALSHIBAYA has never been in the United States and that he had heard that ALSHIBAYA may have been a little too friendly to Germany during the Hitler Regime.

\ ERISTOPP said that MICHAFL ALSHIBAYA has a son-inlaw one, DAVID \CHKHATARASHVILI, residing in the United States and that CHKILUARASHVILI is known in the United States as DAVID \CHATARA. He said that DAVID CHATARA arrived in the United States about 6 or 7 months ago as a Displaced Person and that he is currently residing in New York City. FRISTOPP stated that DAVID CHATARA is a physician, having graduated from a medical school in Russia about 1960.

It is to be noted that according to SIMON ERISTOFF one ! ICHALL ALSHIBAYA was a member of the Georgian Association in Foland and reportedly was a little too friendly with the Germany during the Hitler Regime. It is also to be noted that the !ICHALL ALSHIBAYA known to !RISTOFF has a son-in-law a loctor who arrived in the United States about 6 months ago.

It is to be noted that seconding to T-1 MICHALL ALBHIBAUA is a Soviet agent and that his boviet superior is MEMALL KADIJ, both of whom worked for the florman Gestapo during

World War 11. Further, according to T=1 KICHAFL ALSHIBAUA has a brother-in-law who is a doctor and who came to the United States about one year ago.

The files of the New York Office failed to reflect. any derogatory information on DAVID CHATARA and no further information on MICHA: L ALSHIBAUA other than that information set out above.

Confidential Informant T-1 further advised that IVGERI GEG: TCHKORI, the so-called head of the Georgian Government in exile in Paris, France, has no authority over the Georgian Delegation at the International Red Cross and doubts whether GEG: TCHKORI is aware that a Georgian Delegation is attached to the International Red Cross in Geneva, Switzerland. The informant said that GIGETCHKORI is the head of the minority group of the former Republic of Georgia, Russia.
