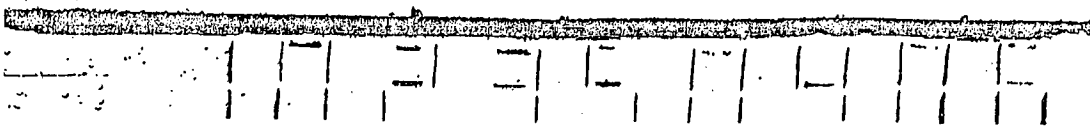

2. Check of the files of this Office disclosed the following pertinent information concerning individuals who are identified with [REDACTED]:

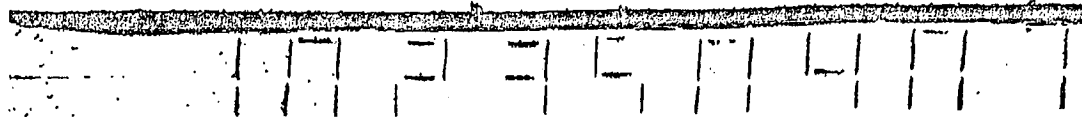

in the above-mentioned report, the information to this Agency by the Army,
this Agency shall be in his allegations, and not current sensitive
information in the field of this Agency's jurisdiction of the
allegations. Since the above information is your Agency's file
file contains the names of proof of his allegations, this Agency will
attempt to obtain at least a portion of these files with a minimum
of expense to the Agency. Therefore, it is requested that permission
be granted by your Bureau to enable the staff of the Agency to

requested that you (British Army) may assist in the information obtained by
this Agency in the above-mentioned report concerning the file or files
mentioned in previous correspondence on this subject to be
