A CHECK OF CIC FILES REVEALED THE FOLL INFO:

1. IN A DEPT ARMY REPORT DATED 13 NOV 50, IT STATES: SUBJ, BORN 4 JULY 00 IN OBERLEUTENDORF, CSR, SERVED FIVE YEARS IN CZECH ARMY DURING WORLD WAR II IN 18 TANK DIV AND LATER TRANSFERRED TO INTEL. ON 9 JUN 45, SUBJ WAS ARRESTED BY CSR PARTISANS IN OBERLEUTENDORF, AND TURNED OVER TO RUSSIAN ARMY, SUBJ WAS HELD IN SEVERAL PRISONS AND LABOR CAMPS IN RUSSIA UNTIL REPATRIATED JUN 55. (B-2)

2. FROM A REPORT DATED 31 AUG 47, ONE ANTON KRATSCHMER, A FORMER GERMAN INTEL SER PERSONALITY, CLAIMED THAT IN 41-42 IN PRAGUE, HE SERVED WITH ONE ALFRED KLAUSNITZER WHO WAS A CAPT AT THE TIME. KRATSCHMER STATES THAT KLAUSNITZER WAS A LETTER AND LATTER SERVED WITH THE SICHERHEITS DIENST (SECURITY SERVICE) IN BUDAPEST HUNGARY. KRATSCHMER SAID THAT MANY FORMER CIS PERSONALITIES WERE, IN 47, EMPLOYED BY THE CZECH INTEL SER UNDER SOV SUPERVISION AND THAT ONE KLAUSNITZER FNU, WHO MAY OR MAY NOT BE IDEN WITH SUBJ WAS ONE OF THEM. THE REASON KRATSCHMER CLAIMED THIS WAS BECAUSE WHILE HE, KRATSCHMER WAS UNDER INTERROGATION HIMSELF BY THE SOVS IN BADEN VEI (ALSO RECEIVED BEI) WIEN, AUSTRIA, HE ALLEGEDLY SAW STATEMENTS SIGNED BY KLAUSMITEER.
