Security Assessment of LNHARP Relations with IFAG

1. A JKLANCE approach to Identity A in WOCORK for the purpose of learning the details of LNLUTE relations with IFAG would necessitate prior clearance from LNSHOB. This would require a complete explanation for the JKLANCE concern over the handling of information originating with an LNLUTE organization and the security of the relationships between the LNLUTE employees Identity A and Identity B and the suspected EGIS agent Identity C. These are areas of primary jurisdiction and security responsibility of LNSHOB and LNWILT.

2. Headquarters is of the opinion that JKLANCE should not initiate unilateral investigations into them. Headquarters recommends that the case be brought to the attention of LNWILT commander for whatever disposition he desires, and continue to monitor CASEPARATE's actions in respect to the letter-writer. Under these circumstances, it would seem to be proper to turn the mail channel over to CASEPARATE also.
