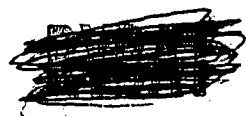

1. Forwarded herewith is latest letter received from BOMI. From the tenor it appears that this is the last letter which we will receive.

2. Both CASEPARATE and LNLGUE have received copies of all letters received. LNLGUE does not plan to pursue the matter, but will warn all concerned to take the necessary security precautions when dealing with IFAG.

3. Re DIRECTOR-099058, 5 January 1971, and the possibility that BOMI may be identical with former CAPRAIRIE team member Arnold V. MOSTILLAMI (P): RINGBAUER, who was directly involved in the MOSTILLAMI case and knew his (now divorced) wife, well, contacted MOSTILLAMI's wife to learn about his current situation and activities. The information obtained plus handwriting comparison seems to eliminate MOSTILLAMI as a suspect.

4. [] considers this activity closed as far as JKLANCE is concerned. CAWHISPER will continue to investigate the activities of the personalities concerned.
