2. CAPELIN REQUESTS CLEARCUT DECISION RE HIS FUTURE RELATIONSHIP WITH RICHTER:
 - A. BREAK CONTACT ON BASIS PRESSURE OF WORK; REFUSE ACCEPT MONEY.
 - B. CONTINUE AS AT PRESENT, REPORTING TO US IMMEDIATELY ALL EEIS AND INFO GIVEN, ORAL OR WRITTEN.
 - C. CONTINUE REPORTING AS PER B WITH LIMITATIONS OF SUBJECTS IMPOSED BY US.
 - D. DEVELOP SOURCES IN GIS FOR FUTURE EXPLOITATION ONCE GERMANY SOVEREIGN. (CAPELIN COMMENTS PRESENT EEIS AND INFO OBTAINED FROM GERMANS OF LITTLE INTEREST).
