REDSOX CART AEBATH

1. FOLLOWING TWO POINTS MAY MAKE ACQUISITION GERMAN CITIZENSHIP LESS NECESSARY FOR AECAPELIN:

A. ALTHOUGH AECAPELIN AS GERMAN CITIZEN COULD LEGALLY RESIDE FRANCE FOR THREE MONTHS PRIOR OBTAINING FRENCH VISA, SIMILAR CASES INDICATE IT SIMPLER AND PREFERABLE FOR AECAPELIN TO MAKE APPLICATION FOR VISA BEFORE LEAVING FOR FRANCE. IF EVEN WITH AID OF THEOLOGICAL INSTITUTE OR WORLD COUNCIL OF CHURCHES VISA DELAYED SEVERAL MONTHS HE COULD COME FRANCE, RETURNING TO GERMANY TO PICK UP VISA AT PLACE OF APPLICATION WHEN IT READY.

B. NEW DP TRAVEL DOCUMENT RECENTLY ISSUED IN FRANCE CALLED FRENCH TITRE DE VOYAGE ^oPUR REFUGIES PROVIDES RIGHT TO DOMICILE FOR AS LONG A PERIOD AS DP IDENTITY CARD VALID, REGARDLESS OF INDIVIDUALS WHEREABOUT IN MEANTIME. IF GERMAN HAVE EQUIVALENT THIS WOULD SOLVE AECAPELIN'S DIFFICULTIES IN RETAINING RIGHT TO GERMAN DOMICILE WITHOUT ACQUIRING GERMAN CITIZENSHIP.
