1. AECAPELIN 1 STATES FRENCH CONSULATE READY GRANT VISA IN 23 WEEKS PROVIDING HE ABLE PROVE HAS CA 3-4,000 DM AS SECURITY IN GERMAN BANK.
2. ALTHOUGH HAS APPROVAL FROM SCHOOL AND READY GO, REQUESTS POSTPONEMENT VIEW CANADIAN NON ACTION TO DATE PERMIT WIFE IMMIGRATE CANADA. IF WIFE NOT GRANTED CANADIAN VISA, SHE WILL ATTEMPT IMMIGRATE U.S. MEANTIME AECAPELIN FEELS OBLIGATED REMAIN. IF TRANSFERRED PARI HAS DECIDED SELL HIS GERMAN DWELLING AND FURNITURE AND HE NOW SOLICITING PROSPECTIVE BUYERS.
3. ALTHOUGH AWARE FOLL UNTIMELY, WISH RECOMMEND HQ RECONSIDER WISDOM AECAPELIN TRANSFER PARI. GENERALLY RECOGNIZE HE CAN BE USEFUL [ ] ALTHOUGH DETAILS HOW AND TO WHAT EXTENT UNKNOWN MOB. NEVERTHELESS INCLINED DOUBT HIS UTILITY PARI GREATER TO KUBARK THAN HIS UTILITY MUNI AND FREELY CONCEDE HE SHOULD GO PARI

A. IN MUNI HIS CONTACTS LONG ESTABLISHED AND OF PROVED PRODUCTIVITY IN UKE FIELD. HIS COVERAGE THIS FIELD NOT REPLACEABLE BY BEST EFFORTS OTHER MOB SOURCES. AECAPELIN 1 UNABLE SUGGEST SUCCESSOR AND WE FEEL CANDIDATES PARA 1 REF B UNSATISFACTORY REPLACEMENTS FOR REASONS GIVEN, EXCEPT PERHAPS FOR PURPOSE SUPPLEMENT AND CONFIRM AECAPELIN INFO.

B. AECAPELIN HAS PRODUCED MUCH CE INFO FOR MOB AND HAS BEEN OUR SOLE WINDOW ON AECANDIOT'S ACTIVITIES. RECENT DEVELOPMENTS INDICATE THAT THE ENIGMA OF AECANDIOT MAY BE CLOSER TO SOLUTION BUT THAT SOLUTION WILL PROBABLY BE LONG POSTPONED IF NOT PRECLUDED BY AECAPELIN'S REMOVAL FROM MUNI.

C. FEARS RE AECAPELIN'S SECURITY STEMMING FROM APPEARANCE FORMER WIFE W GERMANY FAILED MATERIALIZE. ALTHOUGH HE HERE LONG TIME, FEEL HIS STATUS NO LESS SECURE NOW THAN EARLIER.

D. AECAPELIN HAS PROVIDED THE MAJOR PORTION OF BACKGROUND INFO AGAINST WHICH MSGS FROM MOB DA'S TO THE RIS IN UKE FIELD ARE CHECKED, AND HAS PROVED MOST USEFUL IN CONFIRMING AND AMPLIFYING INFO FROM OTHER SOURCES IN THIS FIELD.

4. AECAPELIN ESTIMATES HE PROBABLY NOT ABLE GO PARI TIME FOR NOV COURSE ANYWAY AND HENCE EXPECTS MAKE MAY 56 COURSE. HE STILL EAGER GO BUT AMENABLE PROLONGED STAY MUNI ESPECIALLY IN LIGHT RECENT AECANDIOT DEVELOPMENTS.

8. PROPOSE LCFUUTTER AECAPELIN NEAR FUTURE ESPECIALLY RE  
ZIPPER INVOLVEMENT. FEEL THIS MANDATORY PRIOR TRANSFER PARI AND  
ADVISABLE IF REMAINS MUNI.
