a) ACT. AFELE said over the Saster holidays me had chance to meet with quite a few personalities socially, many of whom have been of interest to the FIS. Among these were Volodymyr DULENKO, Yakow MAKOVETSKYY, Osyp BOYDNYN, Makhail GARTENS, ASAyubiA, AEGAPELIS/1, Volodymyr STAKHIV and a score of lesser personalities. Fis meeting with Compositions for the FIS, reported in SW No. 10, was confined to exchanging Easter preetings and promises to phone. Also as reported in SW No. 10, AC Comparison about Taras HULEM's expected arrival in Germany from America from TOLERKO and was able to furnish the HIS with negative information about the alleged "special school in Holland" from his talks with BIGARNY and MAKOVETSKYY.

b) When Galle remarked that he had noticed Ivan SALVAK (DOB Li July 1921; POB Chodorov, Foland) taking pictures in front of the Ukrainian church on Saster morning, and askeil in the thought SALVAK was doing this on assignment. If whether he thought SALVAK was this for himself as a nobby and was piccably not selling pictures to some intelligence agency. I said he once talked about this with SALVAK and learned from him that the Ukrainian between accused SALVAK of working for some unknown intelligence organization.
