- 4. According to information from a displaced persons form from Germany dated 1951, Franz Schubert, whose address was Renkenberge, Lathen, Kr. Osnabruck, West Germany, lived with his wife, Maria, and his children, Franz, Nikolaus, and Anna. He was listed as a farmer, and his destination was Pennsylvania. (NFI) (CETF/W/ULO)
- 5. The files and indices of the Directorate of Operations surfaced no record of Semen Pawlenko. Additionally, there was no
