INFO OBTAINED RELIABLE SOURCE IN AUSTRIA AND AS TELEKI NO LONGER IN CONTACT
WITH PETER DO NOT FEEL LATTER'S SECURITY ~~ENGINEER~~ IMPERILED. EMPHASIZE THAT WE
INFORMED [] ON PURELY PERSONAL BASIS IN SPIRIT OF COOPERATION.

6. FYI: SOURCE IS RECENT DEFECTOR HUNGARIAN AVR. WE DESIRE CONCEAL HIS IDENTITY
AND OUR CONTACT WITH HIM UNTIL DEBRIEFING COMPLETED. THEREFORE JAVELIN NOT YET
INFORMED AND IMPORTANT [] NOT INFORM THEM, SINCE IT LIKELY [] OR []
WILL APPROACH [] FOR TRACES TELEKI OR PETER, HE SHOULD NOT REVEAL OUR INVOLVEMENT
VENUS CASE NOR PRIOR KNOWLEDGE RE PRESENT TELEKI CASE.
