2. FOR [] INFO RE TELEKI BASED [Belgian] AGENTS CONTACTS TELEKI MARCH 51 TO MAY 52.
3. AGENT RECRUITED BY JOSEPH EROS LATE 49 TO PENETRATE RIGHT WING HUNGARIAN EMIGRE ORG, MHBK, HEADED BY GENERAL ZAKO, SUBSEQUENTLY TURNED OVER TO ANDRE FULOP JULY 50, IN MARCH 51 INTRODUCED BY FULOP TO TELEKI WHO USED COVER NAME OF SCHUSTER.
4. AGENT AND TELEKI HAD INFREQUENT CONTACTS PARIS UNTIL MEETING 18 MAY 52 WHEN JANOS PECSI TOOK OVER FROM TELEKI AND SUBSEQUENTLY PASSED AGENT TO ZOLTAN KOVACS OF HUNGARIAN LEGATION BRUSSELS.
5. LOCAL JAVELIN, KUBARK, [B] MADE ABORTIVE PLAN MARCH 52 ATTEMPT LURE TELEKI TO BELGIUM FOR AGENT MEETING IN ORDER COMPROMISE HIS DIPLOMATIC STANDING WITH HOPE POSSIBLY
