1. CONCUR KUBARK GERMANY SHOULD BRIEF USAREUR AND 66 CIG ANY ZIPPER ASPECTS PONGER/VERBER CASE.

2. SUGGESTED COM BRIEF:

A. KRICHBAUM ASPECT SUFFICIENTLY INVESTIGATED, OUR CONCLUSION PER PULL 5344 (IN 12108) HE NOT RECRUITED, USED BY PONGER AS UNWITTING SOURCE RE EX-ADZEH, POLICE, SD TYPES, AND MEANS PLACING HOETTL IN ZIPPER. REQUEST LEADS DISPUTING THIS CONCLUSION BE GIVEN US FOR EXPLOITATION.

B. HOETTL ALSO PROBABLY NOT RECRUITED, BUT DEFINITELY VIEWED AS POTENTIAL RECRUIT OR EVEN WORTH MAKING EFFORT TO PLACE WITH ZIPPER AS UNWITTING SOURCE PONGER.

C. 66 CIG QUERY FRANZ GROSCHEK EX-ZIPPER NOW KRIPO KARLSRUHE RE MEETING PONGER 18 OCTOBER 1952. OTHER MEETINGS?
