- 4. <u>Fraction</u>. In the event of the evacuation of Germany, you and members of your immediate family residing with you at the time will be given such assistance as can be accorded, resembling that given to American citizens on duty in Germany.
- 5. Secrecy. You will be required to keep forever secret this contract and all information which you may obtain by reason hereof (unless released in writing by the Government from such obligation), with full knowledge that violation of such secrecy may subject you to criminal prosecution under the espionage laws dated 25 June 1948, as amended, and other applicable laws and regulations.

- 6. Instruction Instructions received by you from the Government in briefing or training are a part of this contract and are incorporated herein to the extent that such instructions are not inconsistent with the terms thereof.
- 7. Unauthorized Committments. No promises or committments pertaining to rights, privileges or benefits other than those expressly stipulated in writing in this agreement or any amendment thereto shall be binding on the Government.
- 8. Term. This contract is effective as of 5 September 1952, and shall continue thereafter for a period no longer than your residence in Germany or one year, whichever period is shorter, unless aggner terminated by the Government sither.

  - (b) Without prior notace, in the event of a breach of this contract by your violation of the security provisions hereof or by your otherwise rendering yourself unavailable for adseptable service.
