CONTRACT

The purpose of this contract is to define the extent of the obligations which we incur towards you in availing ourselves of your services. In addition, the contract contains certain commitments to which you must bind yourself before we can consider utilizing such services. In affixing your signature to this document, you will indicate that you have read and understood the terms of this contract and that you willingly commit yourself to all its conditions.

1. In consideration of your services, you will receive a monthly compensation of 700 DM until the expiration of this contract.
2. You will be furnished quarters and utilities at our expense.
3. Expenses which you incur in traveling and in otherwise carrying out your duties will be reimbursed in all cases in which the expenses have been directed and authorized by us. You will be required to render a full accounting of all such expenses in order to receive reimbursement. You will be authorized per diem in the amount of 25 DM while traveling to cover hotel and eating expenses.
4. In the event of the evacuation of Germany, you and members of your immediate family residing with you at the time will be given such assistance as can be accorded, resembling that given to American citizens on duty in Germany.
5. You must pledge your word to keep forever secret this agreement and all information which comes to your knowledge as a consequence thereof. Your attention is directed to the fact that violation of such secrecy may subject you to criminal prosecution under the Espionage Act of 1917 and other applicable laws and regulations. Termination of this contract will not release you from your pledge to maintain secrecy.
6. This contract goes into effect on _____ and shall be terminated one year from that date. At that time, it may be renewed if both parties to the contract so desire. At any time, either party may terminate this contract with written advance notice of one month. Such notice will become effective one month from the date of receipt.
