Mr. President

I have to thank You for the unambiguous answer i got from the Department of Justice regarding my letter to You as to the status of my citizenship. Thus, as a twice certified U.S.A. citizen, i feel duty bound to draw to Your attention the oath published in Reader's Digest, Sept., 1964, p.126, which in my opinion would be more timely, sincere and American-minded than the one i had to recite in 1958 (made me almost laugh because of the bizarre phrases in it). Of course, the phrase " to accept you as our king and sovereign lord " should be changed to:

" to accept you, the people of the United States of America, as our senior citizens (or - fellow citizens), provided ..."

Secondly - and still as a new U.S.A. citizen - i vigorously object to the treatment applied on me since the same year i obtained said citizenship - or was notified so. In my view it is a blatant abuse of some of our basic liberties which makes me to look back to these last seven years as having been almost an outlaw or worse. Since the reason for such misconduct by the responsible officials regarding my private and most intimate life is unknown to me, i.e., has not been revealed to me in unmistakable words, and since i see no end to this deplorable and inhumane state - i have to appeal to the Supreme Court of this country to decide whether You and Your predecessors in this highest executive position have beeg and are acting within the rights entrusted to You by the people of this country regarding the case of me and my family. As the situation is now, i have to renounce the citizenship of a country which destroys my family, makes me almost regularly unemployed and a laughingstock to the whole world.

If You have no knowledge of this case and its cause, You aren't the right man in the White House, but if You knew the facts but didn't stop this public character assassination - then You are a skunk !

Finally, while this case is under investigation - though all the facts should be very well known to the proper authorities - i make You personally responsible for the safety of my person as well as that of the members of my former family. I am fed up with being repeatedly drugged, even beaten up, since i still have some hopes that this country won't experience the horrors of 1984 - or follow in the footsteps of Adolf Hitler - nor would You.

Similar letter goes to the Supreme Court in a few days.
