- (1) On 15 January, 1952, the first two indigenous agents of the LCPROWL APPARAT wireless transmitter section were sent to raide school. Both men are fully cleared and it is planned that they will go into action with the fighting groups of LCPROWL APPARAT in the event of B-Day. One of the men has had considerable previous training in this work, and while the other has not, it is felt that he will be of operational value in about two months. There are other men ready for training once they are fully cleared.
