1. HOLLOCKS HAS BEEN INFORMED BY [] THAT PENDING CHARGES BY HESSIAN PROSECUTOR TRANSFERRED TO JURISDICTION FEDERAL COURTS WHERE CASE DISMISSAL IF FOREGONE CONCLUSION. IN VIEW ABOVE, OUR OBLIGATION FOR SUPPORT OF LEGAL DEFENSE CEASES.
2. HOLLOCKS TERMINATION, INTERRUPTED BY THIS LEGAL COMPLICATION WILL NOW BE EFFECTED WITH PAYMENT OF THREE MONTHS' SALARY. WILLING TO CONSIDER EMIGRATION TO U.S. (ONLY) PROVIDING WE ASSIST IN RE-SETTLEMENT. HE ALSO AWARE OF SPECIAL KUBARK QUOTA PROVISIONS.
3. DESPITE ABOVE, HOLLOCKS PREFERS REMAIN GERMANY. ANTICIPATING TERMINATION, SUBMITTED FOLLOWING COUNTER PROPOSAL: ASKS 70,000 DMS FOR NEW INDEPENDENT PP OPS PROJECT AND TO PROVIDE RESTITUTION LEADING BDJ PERSONALITIES WHOSE REPUTATIONS SEVERELY DAMAGED AND WHO POTENTIAL SECURITY THREATS IF NOT ASSISTED TO EARN LIVELIHOOD. HOLLOCKS AND SIX KEY BDJ PERSONALITIES EXPECTING CONCRETE ASSISTANCE IN WAY OF JOB PLACEMENT AND RESETTLEMENT INSIDE GERMANY. ALL SEVEN FEEL THAT U.S. RESPONSIBLE FOR THEIR PRESENT PLIGHT. HOLLOCKS FEARS ADVERSE
