HIGHLIGHTS OF HESSE LANDTAG DEBATE 18 MARCH ON HESSIAN GOVERNMENT  
 ACTION VS BDJ AND TECHNICAL DIENST:

1. ZINN DECLARED FEDREP AGENCIES INCLUDING OFFICE FOR PROTECTION OF CONSTITUTION DEMONSTRABLY UNEQUAL TO JOB. STATED REASON FOR DELAY IN INFORMING LANDTAG AND ISSUING WHITE BOOK WAS THAT HAD NOT WANTED TO ACT WHILE PROCEDURE PENDING BEFORE FED COURT AND THAT INTERIOR MINISTRY HAD ASKED HIM POSTPONE ISSUE.
2. INTERIOR MINISTER ZINKANN EXPLAINED GOVT MOTIVES FOR OUTLAWING BDJ BECAUSE ORGANIZATION BELIEVED IN CONTACT WITH SOVZONE AGENCIES; LARGE AMOUNTS OF MONEY AT DISPOSAL OF ORGANIZATION. HESSE HAS DEMANDED BDJ BAN IN ENTIRE FEDREP.
3. FURTWÄENGLER, SPD DELEGATE, POINTED OUT PARALLEL BETWEEN PRESENT DAY EVENTS AND 1933.
4. GROSSKOPF, HEAD OF CDU FACTION, ASKED SPD NOT TO MAKE AFFAIR POLITICAL ISSUE, BUT BACK REARMAMENT PROPOSALS WHICH WOULD GUARANTEE SAFETY OF STATE AND KEEP GERMAN YOUTH FROM SUCH ABERRATIONS.
