1. SUBCOMMITTEE OF CONSTITUTIONAL COMMITTEE UNDER CHAIRMANSHIP OF MENZEL (SPD) MEETING 0900 HOURS 25 FEB TO DISCUSS BDJ BAN IN FEDREP.

2. MENZEL WROTE BFV TO FIND OUT IF BDJ RECEIVED 50,000 DM END DECEMBER 52 AS DISPOSAL PAYMENT? RADKE SUGGESTS ONE OF FOLLOWING ANSWERS:

- A. ADMISSION THAT KUGOWN PAID THIS SUM
- B. FLAT DENIAL.
- C. WE DO NOT KNOW.

3. FYI: RADKE SAID LUETH WROTE CIRCULAR TO BDJ MEMBERS POINTING OUT THAT EACH MEMBER LIABLE PROSECUTION FOR ILLEGAL ACTIVITY IF BDJ BANNED IN FEDREP. LUETH ALSO STATED HE RECEIVED 30,000 DM IN DECEMBER 52 TO TIE BDJ OVERPREVENT CRISIS.

4. RADKE SAYS PROBABLY MENZEL AWARE CONTENTS LUETH CIRCULAR AND WANTS ASCERTAIN SOURCE OF FUNDS. ACCORDING TO RADKE, LUETH COULD SAY FUNDS RECEIVED FROM HIS INDUSTRIAL FRIENDS PROVIDED HE HAS
