DATELINED BONN:

BONN--IN ORDER PAVE WAY EVENTUAL RECONSTITUTION BDJ ON FEDERAL LEVEL, REMAINING BDJ LAND ASSOCIATIONS FOUNDED IN BONN FEB 11 AND 12 SO-CALLED WORKING ASSOCIATION (ARBEITERGEMINSCHAFT). HERBERT ROEMER, HAMBURG, ELECTED SPOKESMAN ASSOCIATION.

STATEMENT TO PRESS ISSUED THIS OCCASION SAYS WITH FOUNDATION THIS NEW ASSOCIATION FORMER BDJ FEDERAL EXECUTIVE HAS CEASED TO FUNCTION. LAND ASSOCIATIONS WILL CONSIDER THEMSELVES INDEPENDENTLY ACTING UNITS UNTIL NECESSARY GROUNDWORK FOR BDJ'S RECONSTITUTION ON FEDERAL LEVEL HAS BEEN COMPLETED. IN ORDER MAKE THIS POSSIBLE ALSO THROUGH THE RESUMPTION OF WORK BANNED LAND ASSOCIATIONS, "SUITABLE AND EFFECTIVE" MEASURES HAVE BEEN DECIDED UPON, STATEMENT CONCLUDES.
