1. HEINE JUST TRANSMITTED TO US FIRST COPY AS YET NOT PUBLISHED SPD WHITE BOOK TITLED "BDJ AND ITS TECHNISCHE DIENST." UNDERSTAND ITS DISTRIBUTION WILL BE QUITE LIMITED.

2. WE ATTEMPTING DETERMINE DATE OF RELEASE AND WILL ADVISE.

3. DOCUMENT OF 60 PAGES ATTEMPTS SHOW TIE-IN BETWEEN BDJ AND TECHNISCHE DIENST AND CAST SERIOUS ASPERSIONS ON VALIDITY OF CONCEPT OF PARTISAN ACTIVITIES IN GERMANY. AS FAR AS U.S. INVOLVEMENT CONCERNED, DOCUMENT MAKES REFERENCE THAT AMERICANS GAVE UNSPECIFIED AMOUNTS OF MONEY TO BDJ BUT THAT CONSIDERABLE DONATIONS (INCLUDING 1-TIME GIFTS UP TO 500,000 DM) WERE MADE AVAILABLE BY COCA COLA, REEMTSMA CIGARETTES, BOSCH LICHT AND OTHERS. TECHNISCHE DIENST, OF COURSE, LABELLED AS AMERICAN FINANCED ORGANIZATION. AMERICANS NAMED IN CONNECTION WITH BDJ WERE [] AND []

STATEMENT OF UNNAMED "ACCUSED" WHICH DEFENDS BDJ AS WELL AS TD.
(OUR COMMENT: LEST THERE BE MISUNDERSTANDING, THIS SEEMS TO BE BONA
FIDE STATEMENT WHICH WE BELIEVE TO HAVE SEEN PUBLISHED IN KASSELEG
(ALSO RCVD KASSELER) POST. WE WILL CHECK OUR FILES AND CONFIRM.)

5. SPD'S MOTIVATION FOR PUBLISHING DOCUMENT CAN BE GATHERED
FROM CONCLUSION (SCHLUSS), TRANSLATION OF WHICH WILL FOLLOW IN NEXT
CABLE.
