- 2. HOLLOCKS INFORMED US THAT THERE COULD BE ANOTHER COURSE OF ACTION DURING THE HEARING. THE HESSIAN PRE-TRIAL JUDGE. SCHNEIDER, HAD CONTACTED H'S LAWYER ON 30 JAN. IN ORDER TO ASCERTAIN IF OBJECTIONS TO PROCEDURE WOULD BE RAISED BY DEFENSE.
