1. PETERS SAW [ ] 26 JAN AND MADE FOLLOWING POINTS RE "INCRIMINATING DOCUMENT" WHICH ZINN INDICATED AT MEETING OF LAENDER THAT HE HAD, BUT THE REVEALING OF WHICH WOULD TOO GREATLY AFFECT GERMAN AND ALLIED SECURITY.

A. THINK ZINN HAS 2 AND ONE HALF PAGE DRAFT DATED 3 APRIL 1951 FOUND IN [ ]'S HOME AND WRITTEN BY HIM CONTAINING FOLLOWING INCRIMINATING POINTS:

- (1) MENTION OF A PARKER, STANLEY AND DUNSTON AS CONTACT MEN.
- (2) ALL T/D PERSONNEL MUST BE CHECKED WITH CIC, EUCOM, CID AND SDE.
- (3) ORGANIZATION MUST HAVE STAFF OFFICERS AT EUROPEAN HQ.
- (4) PETERS TO BE COURIER FOR MOST ZONES, DORK LEADER OF EAST ZONE.
- (5) ORGANIZATION TO ESTABLISH COMMUNICATIONS FOR INTELLIGENCE PURPOSES AND TO PENETRATE OTHER ORGANIZATIONS AND PARTIES.

2. PETERS CLAIMS NAMES ON SO-CALLED PROSCRIPTION LIST WERE COPIED FOR HIM BY KRIMINALOBERSEKRETAER SZESNY, MARBACHWEG 105, FRANKFURT, FROM CARD FILES DEPT K-12 FRANKFURT POLICE PRAESIDIUM.

3. OUR COMMENT: WE ASSUME THIS TO BE SAME DOCUMENT WHICH [ ] WAS ONCE TRYING TO REGAIN.
