1. FOLLOWING FROM [] TO [] RE BDJ DISCUSSION
AT LAENDER INTERIOR MINISTERS CONFERENCE HELD BONN 15 JANUARY:

A. ZINNKANN (ALSO RECEIVED ZINNKANN) AGAIN ACCUSED
RADKE OF BFV AS HAVING KNOWN OF BDJ ILLEGAL ACTIVITIES WITHOUT
HAVING TAKEN ACTION. [] REFUSED TO BE DRAWN IN THIS OLD
ARGUMENT WITH ZINNKANN.

B. ZINNKANN CALLED KARLSRUHE COURT ACTION MISCARRIAGE
OF JUSTICE, BUT THIS CONSIDERED PERSONAL FEUD BETWEEN ZINN AND
DEHLER.

C. ZINNKANN CLAIMS TO HAVE UNCOVERED ADDITIONAL INCRIMI-
NATING BDJ MATERIAL WHICH HE WILL PLACE AT DISPOSAL THOSE LAENDER
WHICH HAVE NOT YET OUTLAWED BDJ TO PERSUADE THEM TO TAKE ACTION.

D. ZINN ISSUED GREY PAPERS ON BDJ 6 JANUARY BUT COPY
NOT RECEIVED BY FEDERAL INTERIOR MINISTRY UNTIL 13 JANUARY. ZINN
REFUSED COPY FOR BFV.

2. LEHR AND [] OF OPINION THAT MUCH UNFAVORABLE PUBLICITY
COULD BE AVOIDED IF BDJ ADMITTED MISTAKE IN SELECTION OF SOME OF
ITS LEADERS LIKE LUETH AND HEISER.

3. IN SUBSEQUENT TALK WITH MELLIES, HEINE, MENZEL OF SPD,
[] ASKED THEM TO USE THEIR INFLUENCE TO LET BDJ AFFAIR DIE
NATURAL DEATH, BUT COULD NOT GET DEFINITE ASSURANCE.
