- ON 9 JAN HESSIAN GOVT BANNED AND ORDERED BDJ DISSOLVED.
 REASON FOR HESSIAN ACTION WAS TIE-IN WITH APPARAT. OFFICIAL STATE-
 MENT INDICATED THAT EMPLOYMENT PARTISANS IS AGAINST INTERNATIONAL
 LAW. SINCE GENERAL RULES OF INTERNATIONAL LAW PART OF WEST GERMANY
 BASIC LAW, BDJ HAS VIOLATED WEST GERMAN CONSTITUTION.
- POLICE CONFISCATED ALL FURNITURE AND PROPERTY BDJ FRANKFURT
 HEADQUARTERS.
- MINISTER OF INTERIOR FOR BAVARIA EXPRESSED SURPRISE OF
 HESSIAN GOVT ACTION AND INDICATED NO SIMILAR STEPS PRESENTLY BEING
 CONTEMPLATED BAVARIA.
- SPD BONN HQS REFUSED TO COMMENT STATING THIS IS NOT PARTY

HELP FROM U.S. 9 JAN HESSIAN ACTION WILL ONLY HAVE ADDITIONAL CONSEQUENCES FOR US SHOULD COMPROMISING DATA BE FOUND IN CONFISCATED BDJ PROPERTY. AS YOU KNOW WE HAVE CONSTANTLY PRODDED AND EXERCISED ALL POSSIBLE PRESSURES ON OUR BDJ CONTACTS TO RETURN AND/OR DESTROY ANY DOCUMENTATION WHICH COULD SHOW U.S. BACKING ORGANIZATION. WHILE WE CANNOT GUARANTEE THE VERACITY OF THE ASSURANCES GIVEN US BY BDJ'ERS THAT OUR ORDERS WERE EXECUTED BELIEVE CHANCES FOR ADDITIONAL EMBARRASSMENT NOT GREAT.

6. FRANKFURTER RUNDSCHAU CLAIMS THAT LONG ANNOUNCED ZINN WHITE BOOK WOULD BE PUBLISHED IN JAN. IF PAPER REALLY APPEARS REMAINS TO BE SEEN. IN CASE IT DOES APPEAR WE BELIEVE IT WILL CONTAIN NO OTHER STATEMENTS THAN PREVIOUSLY MADE BY ZINN.
