1. 16 MARCH AP RELEASE BRUNSWICK GERMANY STATES HEINZ ANDERS CHARGED WITH FORMULATION DEATH LISTS LEFTWING LEADERS TO BE LIQUIDATED IN EVENT SOVIET INVASION; WEST GERMANY PROSECUTOR ANNOUNCED DDJ MEMBER DIETER VON GLAHN POSSESSED LIST 100 LEFTWINGERS AND JEWS. 17 MARCH LONDON JEWISH TELEGRAPHIC AGENCY REPORTED BRUNSWICK DISTRICT ATTORNEY OPENED PROCEEDINGS AGAINST 24 YEAR OLD VON GLAHN LOWER SAXONY'S DDJ DEPUTY STATE CHAIRMAN, FOR COPIING CARD INDEX 100 PERSONS IN OLDENBURG-DRESEN REGION "TO BE DONE AWAY WITH ON X-DAY."

2. NAME CHECKS INDICATE VON GLAHN FORMER DDJ OFFICIAL WITH POSSIBLE RFV CONNECTIONS; ANDERS INTELLIGENCE MERCHANT UNRELIABLE REPUTATION.

3. PLEASE ADVISE ON:

A. PUBLICITY GIVEN THESE ANNOUNCEMENTS.

B. WHETHER ANDERS AND VON GLAHN FIGURE IN LEHR DDJ INQUIRY.
