SUBJECT IS MEMO DATED 10 MARCH 1951 FROM C 3 TO 5 コッ J'S COMMENTS FOLLOW:

- 1. MY STATEMENT THAT KMPRUDE MIGHT "REMOVE ITSELF AS OBJECT OF CONTROVERSY WITHIN ANTI-GYPSY CAMP" WAS PERHAPS UNCLEARLY EXPRESSED BUT WAS CERTAINLY NOT INTENDED TO RECOMMEND THAT "PRUDE SHOULD BE WITHDRAWN FROM AREA OF DAY-TO-DAY POLITICAL CONTROVERSY" AS MEMO INTERPRETS IT. IT HAS ALWAYS BEEN CLEAR TO US THAT PRUDE'S VALUE IS AS TACTICAL INSTRUMENT.
- 2. IT HAS ALSO BEEN CLEAR THAT IN OUR TACTICAL USE OF IT PRUDE WILL TAKE OPPOSITE SIDES FROM FUNEEDLE ON MANY IMPORTANT ISSUES. DOES NOT WORRY US.
- WHAT WE FEEL IS HIGHLY IMPORTANT IS THAT PRUDE SHOULD NOT BE DEFLECTED FROM ITS WORK ON THESE ISSUES BY BECOMING SIDETRACKED INTO A FIGHT WITH FUNEEDLE AS SUCH. PRUDE IS NOT BIG ENOUGH TO PICK FIGHT WITH FUNEEDLE ORGANIZATION AND HAS SUFFERED IN LCLAVAR EYES BY APPEAR-ING TO BE ENGAGED IN SUCH FIGHT, THEREBY SPLITTING ANTI-GYPSY FRONT.

A. NO TRIMMING ON ANY ISSUES FJCAPE WISHES PRUDE TO PURSUE AS TACTICAL INSTRUMENT. ON THIS AM SURE WE AGREE.

- B. AVOIDANCE OF COMBAT WITH FUNEEDLE ITSELF, IF NECESSARY BY TURNING OTHER CHEEK OR IGNORING FUNEEDLE ON BASIS THAT IN THE OF CONFLICT EVEN IF NOT NOW FUNEEDLE AND KMPRUDE WILL BE SHOULDER TO SHOULDER.
- 5. AM NOT CLEAR WHETHER ABOVE IS MEANING TO BE READ INTO MEMO'S STATEMENT THAT PRUDE "SHOULD CONTINUE TO ADOPT DEFENSIVE LINE IN ANY FUTURE CONTROVERSIES WHICH MAY ARISE WITH ANY POLITICAL PARTIES". PRUDE WOULD UNDOUBTEDLY MAINTAIN THAT ITS LINE WAS NOW DEFENSIVE; BUT IT THREATENS TO BECOME DEFENSE WITH PURSUIT AND IN SUCH MANEUVER PRUDE NOT ONLY FORGETS ITS OBJECTIVES BUT IS GETTING BADLY BURNED.
- 6. PLEASE CONFIRM THAT PARA 4 IS LINE YOU MEAN PRUDE SHOULD TAKE, OR AMEND PARA 4 AS YOU DEEM SUITABLE. CONDUR IN REMAINDER OF MEMO.
- 7. THIS CABLE IS NOT INTENDED TO TOUCH ON QUESTION OF PRINCIPLE WHETHER NOW OR LATER FJCAPE SHOULD ATTACK FJNEEDLE. IT IS CONTENTION HWOEVER THAT PRUDE IS NOT PROPER INSTRUMENT AT LEAST IN PRESENT STAGE OF DEVELOPMENT FOR SUCH FIGHT WHICH SHOULD BE CARRIED ON BY MORE SUBTLE MEANS.
