- 7. Were certain individuals from another project physically threatened by Apparat people? (Sallasa incident)

- 9. Are there other similar corporations providing cover for other projects?
- 10. Eight months before the field assessment of the project, Peters was reported in German newspapers as being the leader of a resistance organization. When did you know of this?
- 11. At least one leader of the Apparat was uncleared and this was uncovered in a CIC-CE check. In view of this successful CE operation, why would you "emphatically reject" a later proposal for a CE check?
- 12. In view of your statement yesterday that the Frankfurt police force was filled with SPD members, do you think the local police checks and inquiries of potential Apparat members was wise or secure?
