

I, Heinrich Lienhard, do hereby acknowledge that I have this date received the sum of DM 5,523.00 (five thousand, five hundred and twenty-three Deutsche Marks) from the Government of the United States of America. In accordance with the agreement under which these funds were entrusted to me, I have purchased with these funds on behalf of the United States Government one Volkswagen Export, motor number 10473140, chassis number 10391119, license number AH41-5504, Kraftfahrzeugbrief No. 6016632.

In consideration for the delivery of these funds to me and for the granting of this vehicle into my custody and in consideration for such other benefits as I have received or shall receive from the Government of the United States, its Agencies or representatives, I do hereby agree as follows.

It is understood and agreed that this vehicle, although officially registered in my name, is now and will remain the sole property of the United States Government; and that it is to be held by me subject to the direction of the United States Government or its authorized representatives and that I have no personal proprietary interest in or claim upon this vehicle; and that in the event of my death or disappearance, or at such other time as the United States Government or its authorized representatives shall designate at its discretion, this vehicle shall be returned into the possession of the United States Government, and that neither I, nor my estate, nor my heirs, shall have any claim upon it.

It is further understood and agreed that this vehicle may not be sold, pledged, or otherwise obligated by me or my representatives or agents for any reason whatsoever, without specific authorization in writing from the United States Government or its authorized representatives.

It is further understood and agreed that this contract shall not be construed to give to me, or my agents or representatives any rights or privileges not specifically set forth herein; and that I shall be personally responsible and liable to the United States Government for the proper custody of this vehicle.

It is understood and agreed that in addition to this acknowledgement, directed to the United States Government, for receipt of these funds I will also be required to affix my signature to a duplicate receipt (for these new funds) to which the firm Selinger & Co. G.m.b.H., acting on behalf of the United States Government, appears as the source of these funds. In signing this duplicate receipt with Selinger & Co. G.m.b.H., I fully understand that the purpose of this duplicate receipt is to be used only, if so directed by the United States Government and/or its authorized representatives, in the event of legal action arising out of my possession and/or disposition of these funds.
