WHO ARE WE?

We are Americans of various backgrounds, traditions and experiences, representing various national groups. We have formed a National Committee against Nazi War Criminals and Nazism in America. In our committee are people active in various fields.

WHAT IS OUR AIM?

We will never forget that tens of millions of people of all nationalities were killed or wounded in the second World War. Hitler and the Nazis, who were responsible for that terrible war, also brutally slaughtered civilians in the millions -- amongst them were older men, women and children.

Although some of the Nazi war criminals were punished after the Nuremberg trials, the world is shocked to learn, 15 years after the war, that countless war criminals have still gone unpunished. While some of these criminals are only now (belatedly) being arrested in West Germany, many of the top war criminals are still free and even hold top positions in the West German government. Others live freely in England, Spain, Portugal, Austria, Egypt, France, Canada, various Latin and South American countries and in our OWN country. In most cases they do so with the knowledge and protection of these governments. We share the growing concern of large numbers of Americans who are worried about the war criminals living in our country with the apparent approval of the state department.

Our committee hopes to work with any and all individuals and groups to bring about the extradition of these criminals so they can stand trial in those countries where their crimes were committed. Failure to do so means that we are accomplices in shielding war criminals. More than that, it gives moral encouragement to native fascists of all types, including the Nazis who openly advocate a policy of genocide against Jews and Negroes.

HOW DO WE PROPOSE TO ACHIEVE OUR AIM?

Our committee will expose the Nazi criminals living in our midst. We shall give names, places of residence and expose the nature of their crimes. In this way we hope to arouse the conscience of the American people in all walks of life. We hope that recipients of this message will bring information to the attention of their neighbors, labor unions, fraternal societies, churches and synagogues and particularly to the attention of senators and congressmen.

NAZI WAR CRIMINALS LIVING IN THE USA EXPOSED BY PROMINENT AUTHOR

EXCERPTS FROM THE PAMPHLET, "NAZI WAR CRIMINALS AMONG US"
by Charles R. Allen, Jr.

Mr. Allen who served with the U. S. Army intelligence from 1946 to 1948 is a free lance journalist whose articles have been widely published in such magazines as the Nation, the New Statesman, (London) Colliers, The Christian Century, Jewish Currents and others. Here we present the names exposed by Mr. Allen, the countries where these criminals are charged with war crimes, and the places they are living in now. We will be happy to furnish more detailed information, including the nature of the crimes with which they have been charged.

1) Dr. Gustav Hilher, one time deputy to Nazi Foreign Minister Joachim Ribbentrop, maintains residence in Washington, D. C. Until recently his phone number was STerling 3-3486. It is now an unlisted number.

2) Franciszek Huschel, a major in Hitler's Wehrmacht after Poland's surrender. He has been charged with terrible crimes against the Byelorussian people. He lives in the Brownsville section of Brooklyn.

3) Andrija Artukovic, former fascist leader in Yugoslavia, charged with being one of the major figures in the murder of 600,000 in Yugoslavia. Although the Yugoslavian government has repeatedly asked for his extradition since 1951 so that he can stand trial for his crimes, he lives peacefully in Los Angeles, California.

4) Viorel Trifa, now known as Bishop Valerian, ecclesiastical head of the Romanian Orthodox Episcopate of America. Resides in a small town called Grass Lake, Michigan, 50 miles due west of Detroit. U. S. Congressman Seymour Halpern (R. N. Y.) said on March 1, 1962 that Valerian had played a leading role in the Fascist Nation Union of Romanian Christian Students.

5) Nicolae Malaxa, accused of being a key figure in the 1941 Iron Guard pogrom (in Romania) which resulted in the murder of an estimated 8,000 Jews. Malaxa lives in a \$2,000 a month apartment in Manhattan having his office in Wall Street.

6) Alfred Skrodelis is a fugitive of justice from Latvia, charged with war time crimes. He is a pastor of the Latvian Evangelical Church in Canada, who, while living in Hamilton, Ontario, serves the parish of the Church of Christ in Detroit.

7) In a document produced in Riga, Latvia, where charges are presented against Alfred Skrodelis, there is a listing of four other persons alleged to have been Nazi collaborators. They are Karlis Sautins of Cleveland, Peteris Nesaule of Indianapolis, Arnold Ernsten of San Francisco and Edmund Match (Mac), in Tacoma, Washington.

8) Karl Linnas lives in Suffolk county in the village of Greenlawn. He is a fugitive from Esthonia, charged with war crimes.

9) Jurgus Bobelis, aged 67, has been accused of war crimes by the Lithuanian courts. He lives in Dorchester, Mass.

10) Kazimieras Palciauskas, also accused by the Lithuanian courts lives in the U. S. A. The same is true of Stasys Zakevicius, 54 years old. He now lives in Los Angeles under the name of S. Zymantas. Mykolas Birziska lived with Zakevicius in Los Angeles until recently. Jonas Slepety, former Minister of the Interior under the Nazi appointed Lithuanian Activist Front, is now living in Long Island City. Mecis Pashkiavicius, 59 years old, now lives in Chicago at 3344 W. Irving Park Boulevard. Like the others, he too has been accused of serious crimes against the people. Juezas Ambrazevicius, is one of the most important war criminals from Lithuania. He now lives in New York.

These excerpts are given in greater detail in Mr. Allen's pamphlet. These are daring charges. A number of outstanding Americans, including congressmen have spoken up demanding government action.

We hope in a small way to honor the million of victims of the last world war by exposing the war criminals living in our midst.

We also hope to keep our country pure, preserve our great democratic traditions, protect our youth by arousing the conscience of all America by asking our government to act and act with speed. We feel that this is the least we owe to our men and women who gave their lives so that Nazism and its evil doings shall forever be ended.
