1. WE ARE CURRENTLY MAINTAINING CALLIKAK COVERAGE ON WILLI HERMAN LITZENBERG [REDACTED], AN UPHILL STAFFER RESIDING IN WUERZBURG. THE COVERAGE IS AT THE REQUEST OF UPHILL IN CONNECTION WITH THEIR INVESTIGATION OF UJDYROT WITH WHOM LITZENBERG IS IN CLOSE CONTACT.

2. IN AN INTERCEPT JUST RECEIVED, LITZENBERG AND JUERGEN C. JAGLA /POSSIBLY [REDACTED] AN EDITOR RESIDING IN KOELN, MOLTKESTR. 86, DISCUSSED THE 1 SEPTEMBER STERN ARTICLE, QUOTE DER MANN OHNE NAME UNQUOTE. JAGLA, WHO APPARENTLY IS A PRINCIPAL AGENT FOR LITZENBERG, MENTIONS THAT THE ARTICLE IS ABOUT WENGER AND ASKS IF LITZENBERG KNOWS WHERE THE LEAD TO THE STORY ORIGINATED. JAGLA THEN GOES ON TO SAY QUOTE FROM YOUR FIRM UNQUOTE. HE TELLS LITZENBERG THAT HE HAS POSITIVE KNOWLEDGE THAT THIS IS TRUE, AND ASKS LITZENBERG NOT TO TELL ANYONE ELSE ABOUT IT. ACCORDING TO JAGLA, QUOTE DER SPIEGEL UNQUOTE HAD THE STORY FIRST BUT WAS AFRAID TO GIVE IT FULL PLAY IN VIEW OF THEIR RECENT DIFFICULTIES. DER SPIEGEL GAVE THE STORY TO THE STERN BUT ADVISED THEM TO CHECK WITH A FEW PEOPLE FIRST. THE RESPONSIBLE MAN FROM THE STERN THEN CONTACTED UPHILL /QUOTE DIESER FIRMA UNQUOTE/, AND THE LATTER SAID O.K., QUOTE IF YOU PRINT THE ARTICLE, WE ARE IN AGREEMENT UNQUOTE.

3. SINCE WE KNOW NEXT TO NOTHING ABOUT JAGLA, WE CANNOT EVALUATE HIS STATEMENTS BUT PLAN TO DISCUSS THE CONVERSATION WITH ALIAS FLEMING AT THE FIRST OPPORTUNITY. EVEN IF THERE IS ABSOLUTELY NO BASIS IN FACT, WE CONSIDER IT SIGNIFICANT THAT SUCH STORIES ARE CIRCULATING. WE WILL REPORT PROMPTLY ANY ADDITIONAL INFORMATION RECEIVED AND REQUEST NOTIFICATION FROM ADDRESSEES IF SIMILAR ITEMS COME TO THEIR ATTENTION.
