Subject has had debriefing experience in the economic field and could possibly be used in that field for FI purposes. Subject has also had police experience and service and would have in all probability contacts to ar within law enforcement agencies

(2) Does Subject have "stayability" in event of war? Would he be subject to draft?

Subject would not under ordinary circumstances be subject to draft largely because of his age (Born 1896). Although ICCASSOCK is not as widely known for its anti-Communist activities as some other Berlin projects, it is sufficiently pin-pointed to make it highly uhlikely that personnel could remain or would be of any operational use to KUBARK in the event of Communist cocupation.

(4) Describe briefly for what purposes Subject is being used and has been used in past by KUBARK.

Subject was picked up by KUBARK after his position with HICOG as an Economic debriefer was cut out. He was first contacted by us in Movember 1950 for REDCAP debriefing assignment. In September 1953 he was transferred to the LCCASSOCK project in the capacity of Security Officer for the project because of his earlier police and investigative training. He has served in this capacity

Wife and adult daughter presumably are aware of the intelligence activity of LCCASSOCK. In addition two or three LCCASSOCK associates, who themselves are witting, also know of the intelligence aspect of the project.

No information. Subject was given a low security number at Berlin Base through which to seach the case officer in case of emergency.

In view of commitments made to subject for evacuation it is presumed that contact would be continuous. Ho special arrangements have been made.

Subject is haid 1000 Marks per month in West German Marks.
