Cadrey claimed to have story, which all he would reveal only to cell case officer

1. MANAGED TO SEPARATE CAUTERY 1 FROM COMPANIONS AND [unclear] AND MET HIM ALONE 3 JAN. CLEAR THAT CLAIM OF INFO PARA 3 REF A MERELY EXCUSE TO USE FORMER CASE OFFICER FOR SOUNDING BOARD FOR SUGGESTIONS RE MOBILIZING MORE GERMAN RESOURCES FOR SUPPORT CADREY WORK AND DESIRE DISCUSS POLICY WITH BOB AT TOP LEVEL. WE CONVINCED HE FEELS NO LACK CONFIDENCE [unclear] BUT USED THIS TACK IN HOPE GETTING ADVICE HELPFUL TO SUCCESSFUL INITIAL APPROACH TO BOB ON THIS PROBLEM. ALLEGEDLY CABANJO CAME MERELY AS FORMER ASSOCIATE [unclear] AND INTERESTED MEMBER DISCUSSION GROUP ON THIS TOPIC. CAUTERY 1 DENIED KNOWLEDGE ANY INSIDE CABANJO INFO ON [unclear] CASE, BUT SINCE WE AVOIDED MEETING CABANJO CANNOT BE SURE SUCH INFO DOES NOT EXIST.

2. MADE CLEAR TO CAUTERY 1 NEITHER [unclear] NOR [unclear] COMPETENT DISCUSS ASPECTS HIS PRESENT WORK AND THAT HIS PROPER COURSE WAS THROUGH CHAMBERS. POINTED OUT IF HIS CADREY PERIODIC REPORTS TO BOB NOT GETTING HOPED FOR REACTIONS SHOULD SHARPEN PRESENTATION IN ONE CONCISE PAPER AND DIRECT CASE OFFICER PARTICULAR
