I MET WITH JOBERT THIS MORNING, SEPTEMBER 7. AS USUAL I FOUND CHARMING BUT SOMEWHAT ELUSIVE.

JOBERT CONFIRMED THAT HE PERSONALLY WOULD GO TO THE FOREIGN MINISTERS! MEETING IN COPENHAGEN NEXT WEEK, ABOUT WHICH THERE HAD BEEN SOME DOUBT. PER GENERAL SCOWCROFT'S TELEPHONE CALL TO ME. I SAID YOU WERE DISAPPOINTED AT JOBERT'S LACK BE RESPONSE TO DISCUSSIONS YOU HAD HAD AND TO THE DRAFT MADE HE SAID HE WAS NOT IN A POSITION TO DISCUSS AVAILABLE TO HIM. THE SPECIFICS OF THE FRENCH POSITION UNTIL AFTER THE NINE HAD REACHED A COMMON POSITION IN COPENHAGEN. HE THEN MADE ONE OF HIS CRYPTIC COMMENTS, IN THIS CASE ABOUT PRELIMINARY INOPPORTUNG CONTACTS BEING MADE WITH THE NINE BEFORE THEIR COMMON POSITION WAS ESTABLISHED. HE SAID HE HAD BEEN CONCERNED TO HEAR THAT YOU HAD TOLD THE BRITISH, WHO NATURALLY PASSED IT ON TO THEIR EUROPEAN PARTNERS, THAT YOU OBJECTED TO THE NINE MEETING TO ARRIVE AT SUCH A COMMON POSITION. IF US WERE IN FAVOR OF THE NINE, AS WE OFTEN CLAIMED, WE SHOULD NOT OBJECT TO MEETINGS OF THE NINE TO ARRIVE AT COMMON POSITIONS. NOR COULD WE EXPECT THE NINE TO ESTABLISH THERE POSITIONS WITH TEN (E.E. THE US).

IN ANY CASE HE SAID THE NINE EXISTED, AND THERE WOULD BE MANY SUCH MEETINGS. HE WANTED TO SUGGEST IN THE SPIRIT OF FRIENDLY COUNSEL THAT WE NOT PUT DURSELVES IN THE POSITION OF SEEMING HE REPEATED THIS THOUGHT SEVERAL TIMES TO OBJECT TO THESE MEETINGS. IN THE CONVERSATION. EVEN IF OUR OBJECTIONS WERE ONLY FOR TACTICAL 豫録RPOSES, AS HE SAID HE SUSPECTED, HE THOUGHT THE TACTICS WERE SUCH DBJECTIONS COULD ONLY RESULT IN THE EC DEFINDING ITSELF MORE AND MORE BY OPPOSTION TO THE UNITED STATES. HE IMPLIED HE DID NOT WANT THIS ANY MORE THAN WE PRESUMABLY WOULD.

I DO NOT KNOW WHAT EXACTLY WAS SAID TO THE BRITISH OR WHETHER JOBERT IS INTERPRETING IT CORRECTLY. IF HE WAS REFERRING TO WHAT SIR BURKE TREND WAS TOLD, AS REPORTED IN STATE 158268. #OBERT HAS EITHER MISUNDERSTOOD OUR POSITION OR IS CHOOSING

TO MISINTERPRET IT. IN EITHER CASE WOULD YOU LIKE ME TO PASS HIM ANY MESSAGE FROM YOU TO CORRECT THE RECORD BEFORE HE LEAVES FOR

COPENHAGEN? I SAID THERE COULD BE NO GROUND FOR DOUBTING OUR SUPPORT FOR THE EC NOR DID WE DBJECT TO THE NINE MEETING. WHAT WE HOPED TO AVOID, HOWEVER, WAS BEING FACED WITH A FAIT ACCOMPLITE A JOINT POSITION OF THE NINE ON THE DECLARATION ON WHICH WE WOULD NOT BE ABLE TO EXCHANGE IDEAS UNTIL IT WAS TOO LATE BECAUSE THE EC POSITION WOULD HAVE HARDENED AND NO DNE ON THEIR SIDE WOULD BE AUTHORIZED TO CARRY ON A BROAD AND GENERAL DISCUSSION OF POSSIBLE CHANGES. JOBERT DENIED WE COULD BE PRESENTED WITH A FAIT ACCOMPLIATINGLY-ING THAT AFTER THE NINE REACHED A COMMON POSITION IT COULD CERTAINLY BE DISCUSSED WITH US. THE QUESTION HOW SUCH DISCUSSION WOULD BE CAR-RIED OUT HE SAID WAS PREMATURE; IT WOULD BE ADDRESSED IN COPENHAGEN.

JOBERT SAID HE FORESAW CLEARLY HOW THIS PROCESS WOULD END. SINCE WE WANTED A PAPER (I.E. A WRITTEN DECLARATION OF PRINCIPLES); THERE WOULD BE A PAPER TO WHICH EVERYONE, WE AND THE EUROPEANS, COULD AGREE. HE RECOGNIZED THAT WE WOULD PREFER A PAPER WITH SOME SUBSTANCE IN IT BUT IMPLIED THAT HE THOUGHT WE WOULD SETTLE FOR THE NINE DID NOT PARTICUALARLY LIKE THE THE PAPER FOR ITS DWN SAKE. DRAFT DECLARATION WE HAD CIRCULATED, JOBERT SAID, WHICH HE REFERRED TO AS THE "SONNENFELD PAPER." HE SAID THE FRENCH WOULD PRESER TWO PAPERS. ONE FOR THE NINE AND ANOTHER FOR THE FIFTEEN COUNTRIES OF THE ATLANTIC ALLIANCE. THIS WOULD HELP TO GET AWAY FROM THE "PACKAGE DEAL" ASPECT OF A SINGLE PAPER WHICH THE FRENCH DO NOT LIKE. IF THERE WERE ONLY ONE PAPER, IT WOULD HAVE TO BE WITH THE FIFTEEN, JOBERT SAID, OR POSSIBLY THE FIFTEEN PLUS ONE. THIS WOULD PROVE THAT THE NINE COULD NOT AGREE ON A PAPER, WHICH WOULD BE A PITY, THOUGH NOT A EARTH-SHAKING CATASTROPHE. SPOKE OF AN UNCERTAINTY AS TO OUR VIEWS AS TO WHETHER THE DECLARATION SHOULD BE WITH THE NINE, THE FIFTEEN, THE FIFTEEN PLUS ONE OR SOME

OTHER COMBINATION. JUBERT HOPES ENGUGH PROGRESS WILL BE MADE IN COPENHAGEN SO THAT YOU AND HE CAN HAVE A USEFUL MEETING WHEN HE COMES TO NEW YORK FOR THE UNGA THE WEEK OF SEPTEMBER 24. I SAID I THOUGHT YOU WERE PLANNING TO BE IN NEW YORK FOR AT LEAST A FRIEF TIME AND THAT I WAS SURE YOU WOULD LIKE TO MEET WITH HIM EITHER THERE OR IN

WASHINGTON. IN SPITE OF JOBERT'S VIEW THAT THE LAUCHING OF THE YEAR OF EUROPE IDEA TOOK PLACE WITHOUT SUFFICIENT PRIOR CONSULTATION OR WARNING TO DUR EUROPEAN ALLIES, HE SAYS HE IS NOT TRYING TO FIGHT THE PAST, THAT HE WELCOMES BILATERIAL TALKS WITH YOU AT ANY TIME, AND THAT HE WILL DO WHAT HE CAN TO HELP REACH ACCEPTABLE SOLUTIONS FOR THE DECLARATION OF PRINCIPLES AND THE PRESIDENT'S TRIP. HE RECOGNIZES THAT CONTINUING BILATERAL CONTACTS BETWEEN THE US AND ITS EUROPEAN ALLIES ARE THE ESSENCE OF DIPLOMATIC LIFE; HIS EFFORTS TO PROTECT THAT GROWING PERSONALITY OF THE NINE ARE NOT INTENDED TO PRECLUDE SUCH BILATERAL CONTACTS.
