2. I SUGGEST CONSIDERATION BE GIVEN AS TO WHETHER WE SHOULD MAKE THEM PAY FOR THE PRIVILEGE, PERHAPS BY USING THE ISSUE OF THEIR HARSH TREATMENT OF PRISONERS.
