1. THERE IS TO BE ABSOLUTELY NO UNAUTHORIZED PRESS OR PUBLIC COMMENT BY ANY DOD PERSONNEL ON THE INCREASED ALERT POSTURE OF U.S. FORCES OR ON ANY ACTIONS RELATED TO DEFCON 3. ALL PRESS AND PUBLIC QUERIES ARE TO BE ANSWERED WITH A POLITE BUT VERY FIRM QUOTE NO COMMENT UNQUOTE. U.S. GOVERNMENT SPOKESMEN IN WASHINGTON ARE ALSO ANSWERING QUOTE NO COMMENT UNQUOTE TO ALL QUERIES AT THIS TIME. FURTHER PUBLIC AFFAIRS GUIDANCE WILL BE PROVIDED WHEN POSSIBLE. ASSURE THAT ALL COMMANDERS, INFORMATION OFFICERS AND OTHER INVOLVED PERSONNEL ARE AWARE OF THIS QUOTE NO COMMENT UNQUOTE POSITION.
