FOLLOWING IS TRANSCRIPT OF AMBASSADOR MCCLOSKEY'S PRESS BRIEIFING AT CAIRO NILE HILTON HOTEL, NOVEMBER 7, 1973:

QUOTE

THIS BRIEFING MIGHT HAVE STARTED A FEW MINUTES EARLIER IF SOMEONE WERE SURE HOW TO WORK THE ELEVATORS IN THE BUILDING.

THE GOVERNMENTS OF THE UNITED STATES AND OF EGYPT HAVE AGREED IN PRINCIPLE TO RESUME DIPLOMATIC RELATIONS AT AN EARLY DATE. THE TWO GOVERNMENTS HAVE ALSO AGREED THAT IN THE MEANTIME THE RESPECTIVE INTERESTS SECTIONS OF THE TWO COUNTRIES WILL BE RAISED IMMEDIATELY TO THE AMBASSADORIAL LEVEL. THE GOVERNMENT OF EGYPT HAS NAMED AMBASSADOR ASHRAF GHORBAL. THE UNITED STATES HAS DESIGNATED AMBASSAEHR HERMANN F. EILTS. THEY WILL TAKE UP THEIR POSTS PROMPTLY.

MR. EILTS, AND THE SPELLING IS EILTS, IS PRESENTLY ASSIGNED TO THE ARMY WAR COLLEGE IN WASHINGTON. HE SERVED PREVIOUSLY AS AMERICAN AMBASSADOR TO SAUDI ARABIA. BE-CAUSE OF THE PRESS OF TIME, IT WAS NOT POSSIBLE FOR ME TO HAVE AT MY FINGERTIPS ANY MORE OF HIS BIOGRAPHIC DATA. BUT THE U.S. INTERESTS SECTION IS GETTING THAT NOW, AND HOPEFULLY WE WILL HAVE IT AVAILABLE TO YOU WITHIN THE EXT 15 23 MINUTES. I WOULD EXPECT IN HIS CASE THAT

HE WOULD BE ON POST HERE IN CAIRO WITHIN 10 DAYS TO TWO WEEKS. IT COULD EVEN BE A LITTLE BEFORE THAT.

NOW IN ADDITION TO THAT BASIC ANNOUNCEMENT WHICH WILL ALSO BE MADE AVAILABLE IN WASHINGTON, I WANTED YOU TO KNOW THAT ASSISTANT SECRETARY SISCO AND HAROLD SAUNDERS OF THE NATIONAL SECURITY STAFF OF THE WHITE HOUSE ARE EN ROUTE TO ISRAEL NOW. THEY WILL HAVE DISCUSSIONS WITH THE GOVERNMENT IN ISRAEL. I EXPECT, ALL THINGS BEING AS THEY NOW ARE, THAT MESSRS. SISCO AND SAUNDERS WILL JOIN THE SECRETARY AND HIS PARTY SOMETIME TOMORROW IN JORDAN.

NOW, LET ME SAY THAT IN CONNECTION WITH THE TRIP OF MESSRS. SISCO AND SNUNDERS TO ISRAEL, THAT WE HAVE... AS BACKGROUND FOR THAT, WE HAVE DEVELOPED SOME IDEAS HERE IN OUR CONVERSATIONS WITH THE GOVERNMENT OF EGYPT ON BOTH SHORT, OR I SHOULD SAY PERHAPS, IMMEDIATE AND LONGER RANGE PROBLEMS, AND THAT WE WANTED TO DISCUSS THESE WITH THE GOVERNMENT IN ISRAEL.

I'LL BE GLAD TO TRY TO ANSWER A FEW QUESTIONS AS FOLLOW-UPS TO THOSE TWO POINTS.

- Q. WHEN DID MESSRS.SISCO AND SAUNDERS LEAVE HERE?
- A. THEY LEFT SOMETIME THIS AFTERNOON, THEY WENT VIA CYPRUS. WE HAD WORD JUST BEFORE I CAME DOWN THAT THEY HAVE DEPARTED CYPRUS SO THAT HEY SHOULD BE IN ISRAEL WITHIN THE HOURS.
- Q. DOES THE DISCUSSION YOU MENTIONED INCLUDE OPENING OF THE BLOCKADED THIRD ARMY AND LIFTING OF THE BLOCKADE IN BAB EL-MANDAB?
- A. I HOPE YOU CAN UNDERSTAND THAT IT WON'T BE POSSIBLE FOR ME TO DETAIL THESE MATTERS FOR YOU INASMUCH AS THEY HAVE NOT YET BEEN COMMUNICATED TO THE GOVERNMENT OF ISRAEL. AS YOU KNOW, OR AT LEAST, THE AMERICAN PRESS TRAVELLING WITH THE SECRETARY OVER THE LAST SEVERAL DAYS, THAT BEFORE WE LEFT WASHINGTON WE SAID THAT AT SOME POINT MR. SISCO, AT LEAST, WOULD GO TO ISRAEL SOMETIME AFTER OUR STOP HERE IN CAIRO.NOW. THAT HAS DEVELLED SOONER THAN PERHAPS Was FIRST ANTICIPATED. AND WE THOUGHT THAT THE GOVERNMENT OF ISRAEL WOULD WELCOME SOME DISCUSSION OF WHAT THE SECRETARY HAS BEEN TALKING OVER HERE TODAY. NOW, HE HAD, THE SECRETARY, SPENT THREE YOURS FROM 10 UNTIL ABOUT 1:20 O'CLOCK WITH PRESIDENT SADAT IN CAIRO TODAY. FOLLOWING THAT, THE FREIGN MINISTER MINISTER, MINISTER FANYI, RETURNED HERE TO THE HILTON HOTEL WITH THE SECRE-**UNCLASSIFIED**

TARY AND SPENT 45 MINUTES TO AN HOUR HERE WHICH DELAYED OUR DEPARTURE FOR LUNCH, AND THE SECRETARY WILL BE SEEING HIM ONCE AGAIN AT APPROXIMATELY 7:30 AT THE FOREIGN MINISTER'S OFFICE, AND THEN THE LAST SCHEDULED THING THIS EVENING IS DINNER THAT THE FOREIGN MINISTER WILL GIVE.

Q. BOB, IS PART OF THE PURPOSE OF THE SISCO-SAUNDERS VISIT TO ISRAEL TO EXPLAIN THE RE-ESTABLISHMENT OF U.S. DIPLOMATIC RELATIONS WITH EGYPT?

A.WELL, I DON'T WANT YOU TO EXCLUDE THAT. CERTAINLY THEY WOULD BE PREPARED TO DISCUSS THAT. I WOULD EXPECT THERE WOULD BE MORE DISCUSSIO THERE ABOUT THE SUBSTANTIVE CONVERSATIONS HERE IN CAIRO.

Q. BOB, WOULD YOU SAY THT THE PURPOSE OF THE VISIT IS TO CONSULT WITH THE ISRAELIS ABOUT PROPOSALS OR PROPOSITIONS RAISED HERE OR TO COMMUNICATE TO THE ISRAELIS DECISIONS ALREADY MADE?

A. THEY WILL BE CONSULTING WITH THE GOVERNMENT OF ISRAEL.

Q. BOB, IF THAT IS SO, WHY ARE THEY NOT COMING BACK TO EGYPT? WHY ARE THEY GOING TO JORDAN? YOU THINK THERE IS A RESPONSE TO GIVE EGYPT FROM ISRAEL?

A. WELL, I DON'T WANT TO RULE THAT OUT WE DON'T HAVE IT SCHEDULED; SI JUST SAID THAT I EXPECT THEM TO JOIN US IN JORDAN TOMORROW AND AFTER THAT, I DON'T KNOW.

Q. WHAT IS IT THAT MADE THE RESUMPTION OF RELATIONS POSSIBLE TODAY?

A. THIS IS A MATTER THAT THE UNITED STATES HAS DISCUSSED WITH BOTH THE PRESIDENT OF EGYPT AND OTHER OFFICIALS OVER THE LAST SEVERAL YEARS AND A MATTER IN WHICH WE WERE ALWAYS INTERESTED IN RETURING T ITS FORMER STATUS. I DON'T WANT TO ATTEMPT TO DELINEATE EVERY CONSIDERATION AND PARTICULARLY NOT ON BEHALF OF EGYPT. I THINK THAT THEY SHOULD AND CAN SPEAK TO THAT FOR THEMSELVES. IT HAS ALWAYS BEEN OUR FEELIN THAT SINCE, OR LET ME PUT IT THIS WAY, OVER THE LAST SEVERAL YEARS, THAT WE WOULD PERHAPS HAVE A MORE EFFECTIVE LINE AND LEVEL OF COMMUNICATION IF BOTH GOVERNMENTS WERE REPRESENTED AT THE AMBASSADORIAL LEVEL.

Q. WELL, WHAT MADE IT POSSIBLE, BOB ...

Q. SOME OF US HAD THE IMPRESSION IN THELAST COUPLE OF DAYS THAT THE RESUMPTION OF DIPLOMATIC RELATIONS HAS BEEN LINKED BY THE EGYPTIANS TO CERTAIN AGREEMENTS, PERHAPS, OR UNDERSTANDINGS THAT HAD TO BE REACHED ON THE IMMEDIATE SITUATION REGARDING THE CEASEFIRE. IS THAT A PROPER ASSUMPTION AT THIS TIME?

A.WELL, I THINK THAT IT SHOULD BE THE GOVERNMENT OF EYGPT TO SPEAK TO THAT. I DON'T KNOW THAT I COULD DETAIL ALL OF THE CONSIDERATIONS THAT WETU INTO THEIR THINKING ABOUT IT, THE FACT THAT IT CAME NOW RATHER THAN LATER, IS A MATTER OF SATISFACTION TO THE UNITED STATES.

- Q. DO YOU EXPECT OTHER ARAB GOVERNMENT TO FOLLOW SOON?
- A. I HAVE NO WAY OF KNOWING.
- Q. HOW DO YOU CHARACTERIZE THE SITUATION NOW, BOB? THE SECRETARY SEEMED TO BE RATHER OPTIMISTIC THIS AFTERNOON. IS HE STILL OPTIMISTIC ABOUT THE CHANCES FOR A SETTLEMENT?
- A. WELL, REMEMBER WHAT I SAID A FEW MINUTES AGO, IN HAVING MESSRS. SISCO AND SAUNDERS GO TO ISRAEL. THE BACKGROUND OF THAT WAS THAT WE DEVELOPED HERE IN ISIRO SOME IDEAS BOTH ON THE IMMEDIATE ISSUES AND ON THE LONGER RANGE QUESTIONS THAT WE FEL WOULD BE OF INTEREST AND WARRANT DISSCUSSION WITH ISRAEL, SO THAT AND INDEED ALL OF THE CONVERSATIONS THAT THE UNITED STATES HAS HAD WITH THE PARTIES OVER THE LAST COUPLE OF WEEKS, PARTICULARLY IN WASHINGTON BUT ALSO IN MOSCOW, WE HAVE FOCUSED A GOOD DEAL OF ATTENTION IN THE FIRST INSTANCE ON THE IMMEDIATE SITUATION ON THE GROUNG BUT ALWAYS KEEPING IN MIND THAT IF THAT COULD BE RESOLVED AND ACCOMMODATIONS REACHED, THAT THAT WOULD MOVE YOU THEN TOWARDS A LONGER TERM QUESTION OF A SETTLEMENT WHICH IS THE BEST WAY I CAN DESCRIBE IT AT THE MOMENT.
- Q. BOB, YOUR ANNOUNCEMENT IS PHRASED IN CONDITIONAL TERMS; IT IS AN AGREEMENT IN PRINCIPLE TO RESUME RELATIONS. ARE THERE CONDITIONS ON ONE OR THE OTHER SIDE THAT HAVE TO BE FULFILLED BEFORE THIS AGIEMENT IS CONSUMMATED.
  - A. I WOULDN'T SAY THAT THERE ARE AND I'D BE WILLING TO ACKNOWLEDGE THAT THE AGREEMENT IN PRINCIPLE WHICH IN FACT THEN ESTABLISHES TWO RESIDENT AMBASSADORS IN PLACE IS DIFFICULT TO DISTINGUISH FROM IN EFFET HAVING DEJURE DIPLOMATIC RELATIONS, SO I DON'T WANT TO LEAVE THE IMPLICATION THAT UNCLASSIFIED.

ANYTHING IS CONDITIONAL HERE.

Q. CAN YOU CLARIFY WHY IT IS CALLED AN AGREEMENT IN PRINCIPLE?

A. THIS IS THE WAY THE SECRETARY AND THE PRESIDENT OF EGYPT AND HIS ADVISORS DECIDED TO LEAVE IT FOR THE PRESENT. NELL I JUST HAVE TO LEAVE IT AT THAT.

Q. BOB, PRESIDENT SADAT TODAY AFTER MEETING WITH DR.KISSINGER SAID THAT WITHOUT DOUBT THAT HE WOULD LIKE THE SECRETARY TO CONTINUE TO PLAY THE MIDDLE MAN IN THE SITUATION. DO YOU FORESEE THE SECRETARY REMAINING ACTIVE PERSONALLY IN HELPING THE TWO SIDES TO BEGIN NEGOTIATIONS?

A. WELL, I THINK YOU CAN ASSUME THAT THE SECRETARY WILL REMAIN PERSONALLY INTERESTED AND TO AN IMPORTANT DEGREE PERSONALLY INVOLVED. WHETHER, WHEN AND IF A NEGOTIATING PROCESS WHICH IN FACT BRINGS THE PARTIES TOGETHER IN SOME FORM AND PL

TO BE AGREED UPON, IT WOULD BE CONSTITUTED, AT A SECRETARY OF STATE LEVEL, I AN INCLINED TO DOUBT. I THINK PROBABLY IT WOULD BE SOMETHING LESS THAN THAT BY COMMON CONSENT OF ALL OF THE GOVERNMENTS, BUT THAT DOESN'T MEAN THAT THE SECRETARY IN WASHINGTON WOULD NOT BE PERSONALLY INVOLVED.

Q. BOB, WHAT IF THE ISRAELIS DON'T LIKE THE IDEA OF ....

- A. OF THE DIPLOMATIC RELATIONS ISSUE, OR ALL?
- Q. WHAT WOULD THE RUSSIAN (UNCLEAR)....

A. WELL, I THINK IN PART THAT HAS TO BE ADDRESSED TO THE GOVERNMENT OF EGYPT. I'VE ALREADY SAID AND I THINK THOSE WHO COVER WSHINGTON HAVE BEN AWARE THAT THE UNITED STATES HAS SOUGHT ON A NUMBER OF SPECIFIC OCCASIONS THAT I CAN PERSONALLY RECALL OVER THE LASI SEVERAL YEARS, THE RESTORATION OF FULL DIPLOMITIC RELATIONS BETEEN WASHINTON AND CAIRO, SO WE WERE PREPAREDOKOR IT AT ANY TIME.

A. I BELIEVE THAT SOMETHING WAS COMMUNICATED THROUGH OUR CHANNELS TO EGYPT EARLIER TODAY.

Q. YOU MEAN ISRAEL!

A. I'M SORRY, TO ISRAEL, AND WHILE AND WHILE ARRANGEMENTS WERE BEING MADE FOR SISCO AND SAUNDERS TO GET TO ISRAEL, INDEED THE ISRAELIS HAD SENT AN AIRCRAFT TO CYPRUS TO PICK UP SISCO AND SAUDNERS TO FLY THEM TO ISRAEL.

## ON ISREAL TO MAKE CONCESSIONS TO THE EGYPTIAN SIDE?

A. I DONT'T THINK THAT WOULD BE A FAIR OR JUSTIFIED CONCLUSION AT ALL. THOSE OF YOU WERE WATCHING IN WASHINGTION WHILE YOU MAY NOT HAVE BEEN AWARE OF THE TOTAL ANATOMY OF THE PROCESS DID KNOW GENERALLY THAT WE ARE HAVING CROSS CONVERSATION WITH THE EGYPTIANS AND WITH THE ISRAELIS, AND TO ANOTHER EXTENT WITH THE SOVIET UNION. I SAID HERE A FEW MINUTES IDMGAT IT WAS ALWAYS ANTICIPATED THAT MR. SISCO WOULD GO BACK THROUGH ISRAEL AT SOME POINT. Q. WELL, WHAT I WOULD LIKE TO KNOW IS WHETHER TODAY YOU ARE ANY MORE OPTIMISTIC THAT THE SITUATION ON THE GROUND CAN BE RESOLVED IN A RELATIVELY SHORT PERIOD OF TIME. DO YOU HAVE ANY REASON AT ALL TO BELIEVE THAT THAT'S POSSIBLE?

A. WE'LL PERHAPS KNOW BETTER AFTER WE'VE HAD CONVERSATIONS WITH ISRAEL, IS THE ONLY COMMON SENSE WAY I CAN ANSWER THAT.

Q. BOB, WITH AGREEMENT IN PRINCIPLE, WILL THE ESTABLISHMENT OF FULL DIPLOMATIC RELATIONS, PERIOD, REQUIRE NOW ANOTHER ANNOUNCEMENT?

A. IF YOU LIKE, WE'LL MAKE ANOTHER ONE.

Q. BOB, ON ASSISTANT SECRETARY SISCO, THERE IS A REPORT THAT HE IS INTENDING TO TRAVEL TO KUWAIT (UNCLEAR).

WE HAD THOUGHT BEFORE WE LEFT WASHINGTON THAT DAMASCUS MIGHT E INCLUDED ON HIS ITINERARY AND IT APPARENTLY IS THE FEELING IN DAMASCUS THAT THEY WOULD RATHER PERHAPS HAVE IT OCCUR AT ANOTHER TIME, SO HE WILL NOT BE GOING TO DAMASCUS, ON PRESENT FORM. KUWAIT, I'M FRANK TO TELL YOU, I DON'T KNOW WHAT THESTATUS OF THAT IS, AND THEN ALL OF THE OTHER STOPS THAT GAVE YOU A WEEK OR SO AGO IN WASHINGTON TO THE BEST OF MY KNOWLEDGE ARE STILL HOLDING.

Q. BOB, YOU JUST SAID THAT THE U.S. WOULD NOT PUT PRESSURE ON ISRAEL. CAN YOU SUGGEST ANYOTHER WAY THAT ISRAEL CAN BE PERSUADED TO WITHDRAW FROM THE OCCUPIED TERRITORIES?

A. NO COMMENT.

Q. THANK YOU.

A. WHAT? THE GOVERNMENT OF THE UNITED AND OF EGYPT HAVE AGREED IN PRINCIPLE TO RESUME DIPLOMATIC RELATION AT AN EARLY DATE. THE TWO GOVERNMENTS HAVE ALSO AGREED THAT IN THE MEANTIME THE RESPECTIVE INTEREST SECTIONS OF THE IWO COUNTRIES WILL BE RAISED IMMEDIATELY TO THE AMBASSADORIAL LEVEL. THE GOE HAS NAMED AMBASSADOR ASHRAF GHORBAL, THE UNITED STATES HAS DESIGNATED AMBASSADOR HERMANN EILTS. THEY WILL TAKE UP THEIR POSTS PROMPTLY.
