UNSYG WALDHEIM, IN PRESENTING FOLLOWING PRESS COMMUNIQUE ON THIRD ROUND OF CYPRUS TALKS AT VIENNA, SAID TALKS WERE MARKED BY "NEW, CONSTRUCTIVE SPIRIT" AND "DESIRE TO SOLVE PROBLEMS ON CONCRETE TERMS." HE SAID THERE COULD BE NO OVERALL SOLUTION AT THIS STAGE BUT "THERE HAD BEEN AN IMPORTANT BREAKTHROUGH IN EFFORTS," NOT ONLY WITH REGARD TO FIVE NUMBERED POINTS IN COMMUNIQUE BUT ON OTHER ITEMS AS WELL TOWARD WHICH "PARTIES HAD A POSITIVE VIEW." ALSO, HE SAID, EARLY DATE FOR NEXT ROUND OF TALKS INDICATES INTEREST OF PARTIES IN REACHING FINAL SETTLEMENT." CLERIDES COMMENTED THAT TALKS "HAD DONE A LOT TO PREPARE THE GROUND FOR A CONSTRUCTIVE FOURTH ROUND." THE GROUND FOR A CONSTRUCTIVE FOURTH ROUND."

PRESS COMMUNIQUE

THE THIRD ROUND OF TALKS ON CYPRUS WAS HELD IN VIENNA FROM 31 JULY TO 2 AUGUST 1975.

PRELIMINARY DISCUSSIONS WERE HELD ON THE POWERS AND FUNCTIONS
OF A FEDERAL GOVERNMENT ON THE BASIS OF THE ORIGINAL GREEK CYPRIOT
PROPOSALS SUBMITTED AT THE FIRST ROUND, THE TURKISH CYPRIOT PAPER
OF 21 JULY AND THE MORE COMPREHENSIVE PAPER PRESENTED BY MR. CLERIDES AT THIS MEETING. FURTHER EXAMINATION OF THIS SUBJECT WILL CONTINUE IN NICOSIA WITH A VIEW TO A FINAL DISCUSSION, TOGETHER WITH THE OTHER ASPECTS RELATING TO THE SOLUTION OF THE CYPRUS PROBLEM, AT THE NEXT ROUND OF TALKS. MR. DENKTASH EXPRESSED HIS VIEWS ON THE COMPREHENSIV

PAPER SUBMITTED BY MR. CLERIDES AND ALSO ON THIS OWN PROPOSALS FOR A TRANSTIIONAL JOINT GOVERNMENT SUBMITTED BY HIM ON 18 JULY. MR. Q ERIDES REFERRENO Objection To Declassification in Full 2012/02/13: LOC-HAK-240-1-5-8

A DISCUSSION OF THE GEOGRAPHICAL ASPECTS OF A FUTURE SETTLEMENT OF THE CYPRUS PROBLEM TOOK HLACE. IT WAS AGREED THAT MR. CLERIDES AND MR. DENKTASH WOULD HAVE FURTHER HRIVATE TALKS ON THIS SUBJECT PRIOR TO THE FOURTH ROUND OF THE CYPRUS TALKS WITH A VIEW TO PREPARING THE DISCUSSION OF THIS MATTER WHICH WILL TAKE PLACE AT THAT TIME.

IN ADD IT ION THE FOLLOWING WAS AGREED:

- 1. THE TURKISH CYPRIOTS AT PRESENT IN THE SOUTH OF THE ISLAND WILL BE ALLOWED, IF THEY WANT TO DO SO, TO PROCEED NORTH WITH THEIR BELONGINGS UNDER AN ORGANIZED PROGRAMME AND WITH THE ASSISTANCE OF UNFICYP.
- 2. MR. DENKTASH REAFFIRMED, AND TIWAS AGREED, THAT THE GREEK CYPRIOTS AT PRESENT IN THE NORTH OF THE ISLAND ARE FREE TO STAY AND THAT THEY WILL BE GIVEN EVERY HELP TO LEAD A NORMAL LIFE, INCLUDING FACILITIES FOR EDUCTION AND FOR THE PRACTICE OF THEIR RELIGION, AS WELL AS MEDICAL CARE BY THEIR OWN DOCTORS AND FREEDOM OF MOVEMENT IN THE NORTH.
- 3. THE GREEK CYPRIOTS AT PRESENT IN THE NORTH WHO, AT THEIR OWN REQUEST AND WITHOUT HAVING BEEN SUBJECTED TO ANY KIND OF PRESSURE, WISH TO MOVE TO THE SOUTH, WILL BE PERMITTED TO DO SO.
- 4. UNFICYP WILL HAVE FREE AND NORMAL ACCESS TO GREEK CYPRIOT VILLAGES AND HABITATIONS IN THE NORTH.
- 5. IN CONNECTION WITH THE IMPLEMENTATION OF THE ABOVE AGREEMENT PRIORITY WILL BE GIVEN TO THE RE-UNIFICATION OF FAMILIES, WHICH MAY ALSO INVOLVE THE TRANSFER OF A NUMBER OF GREEK CYPRIOTS, AT PRESENT IN THE SOUTH, TO THE NORTH.

THE QUESTION OF DISPLACED PERSONS WAS ALSO RE-EXAMINED.

ALT HOUGH BOTH SIDES AGAIN AFFIRMED THAT THEY WERE NOT KNOWINGLY HOLDING UNDECLARED FRISONERS-OF-WAR OR OTHER DETAINEES, IT WAS AGREED MUTUALLY TO EXTEND FULL FACILITIES FOR SEARCHES IN RESPONSE TO INFORMATION GIVEN BY EITHER SIDE.

BOTH SIDES DECLARE THAT THE NICOSIA INTERNATIONAL AIRPORT, WHICH HAS BEEN REPAIRED BY THE UNITED NATIONS UNDER THE AGREEMENT REACHED AT THE FIRST ROUND, CAN BE USED, AS A FIRST STEP, BY THE UNITED NATIONS FOR ITS NEEDS. PRACTICAL ARRANGEMENTS, INCLUDING THE PROVISION OF LIAISON PERSONNEL, WILL BE WORKED OUT BETWEEN UNFICYP AND THE TWO SIDES.

THE FOURTH ROUND OF TALKS WILL TAKE RACE, DUE TO THE SECRETARY-GENERAL'S COMMITMENT IN REGARD TO THE GENERAL ASSEMBLY, AT UNITED NATIONS HEAD QUARTERS IN NEW YORK ON 8 AND 9 SEPTEMBER 1975.
