to DURING QUESTION PERIOD AT WEEKLY SAIGON PRESS CONFERENCE MARCH 15 "PRG" SPOKESMAN WAS ASKED ABOUT FATE OF AMERICANS TRAPPED IN BAN ME THUOT, WHICH "PRG" CLAIMS TO COMPLETELY CONTROL . SPOKESMAN REPLIED, "I HAVE NO INFORMATION ABOUT THE AMERICANS OR ANY FOREIGN RESIDENTS IN BAN ME THUOT PROVINCIAL CAPITAL. BUT I CAN ASSURE YOU THAT ANY FOREIGN RESIDENTS IN SOUTH VIETNAM, EVEN INCLUDING HONEST AMERICANS (BIC) -- ALL THESE PERSONS ARE GIVEN A POLICY OF ASSURANCE AND PROTECTION FROM THE REVOLUTIONARY GOVERNMENT. OF COURSE, WITH REGARD TO AMERICAN MILITARY ADVISERS, THEY WILL BE GIVEN SPECIAL TREATMENT BECAUSE THEY ARE IN A SPECIAL CATEGORY." UNFORTUNATELY, TAPE REEL CHANGE AT THAT MOMENT OBLITERATED OUR VERBATIM RECORDING. UPI CORRESPONDENT WHO ATTENDED PRESS CONFERENCE INFORMED US, HOWEVER, THAT SPOKESMAN WENT ON TO SAY THAT FOREIGNERS WOULD EVENTUALLY BE RELEASED EXCEPT FOR "MILITARY ADVISERS," WHO WERE THERE IN "VIOLATION" OF THE PARTS AGREEMENT. ASKED HOW "PRG" WOULD IDENTIFY THESE "MILITARY ADVISERS," SPOKESMAN REPLIED THAT THEY HAD THEIR WAYS OF KNOWING.

2. AT LATER POINT IN QUESTIONING, SPOKESMAN DENIED ANY ICCS TEAM VAS IN BAN ME THUOT AT TIME OF CAPTURE. ASKED SPECIFICALLY ABOUT IRANIANS AND INDONESIANS FROM ICCS KNOWN TO BE THERE, SPOKESMAN REPEATED THAT THERE WAS NO ICCS "TEAM" THERE, "BUT IF THERE ARE REALLY IRANIAN OR INDONESIAN PEOPLE IN BAN ME THUOT, THAT IS ANOTHER QUESTION. THEY WILL RECEIVE HUMANE AND KIND TREATMENT FROM THE PRG, AS THOSE ACCORDED FOREIGN RESIDENTS IN SOUTH VIETNAM."
