(TEXT) MR SPEAKER OF THE SENATE, MR CHAIRMAN OF THE LOVER HOUSE, MSSRS SENATORS AND DEPUTIES, DEAR GENTLEMEN:

ON-FILE NSC RELEASE INSTRUCTIONS APPLY

TODAY, BEFORE BOTH HOUSES OF THE NATIONAL ASSEMBLY, I WISH TO DESCRIBE THE CURRENT STATUS OF THE PEACE NEGOTIATIONS. ON THE EVENING OF 24 OCTOBER I HAD THE OPPORTUNITY, FOR 2 HOURS TO PRESENT TO OUR COMPATRIOTS THE PEACE SOLUTION WHICH THE COMMUNISTS HAD ADVANCED ON 11 SEPTEMBER.

I EXPOSED ALL THE COMMUNISTS' TREACHEROUS MANEUVERS
REFLECTED IN THIS SOLUTION, WHILE AT THE SAME TIME ASSERTING
THE STAND OF OUR GOVERNMENT AND PEOPLE AND THE BASIC,
CRUCIAL POINTS OF SOUTH VIETNAM. MAY I SUMMARIZE AS

THE COMMUNISTS DEMANDED THAT THE UNITED STATES WITHDRAW FULLY FROM SOUTH VIETNAM -- FROM TROOPS AND EQUIPMENT TO MILITARY BASES--END ITS MILITARY ROLE AND ABANDON ITS VIETNAMIZATION POLICY AND PROGRAM. HOWEVER. THE COMMUNISTS DID NOT SAY WHAT THEY WOULD DO BY WAY OF AN APPROPRIATE RESPONSE. MOR DID THEY SAY THAT THEY WOULD WITHDRAW THE NORTHERN COMMUNIST TROOPS FROM THE SOUTH OR STOP RECEIVING MILITARY AID FROM COMMUNIST IMPERIALISM. IN THE POLITICAL FIELD THE COMMUNISTS DEMANDED THAT A TYPE OF "SUPER GOVERNMENT," CALLED NATIONAL CONCORD GOVERNMENT WITH THREE EQUAL SEGMENTS, BE SET UP FROM THE CENTRAL LEVEL TO THE PROVINCIAL, MUNICIPAL, DISTRICT, VILLAGE AND HAMLET LEVELS, TO CONTROL THE TWO EXISTING GOVERNMENTS -- OURS AND THE SO-CALLED PRORSV--AND TO ORGANIZE GENERAL ELECTIONS. DRAFT A NEW CONSTITUTION AND ESTABLISH ENTIRELY NEW INSTITUTIONS (COW CHEES), THUS ABOLISHING OUR PRESENT CONSTITUTION AS WELL AS CONSTITUTIONAL AND LEGAL INSTITUTIONS.

IN SHORT, IN THE COMMUNISTS' 11 SEPTEMBER SOLUTION WE SEE CLEARLY THAT THEY HAVE UNDEVIATINGLY REASONED, IN THEIR OWN DECEITFUL WAY, THAT:

1--THE UNITED STATES HAS BEEN THE AGGRESSOR IN THE SOUTH AS WELL AS IN THE NORTH. IT MUST THEREFORE BEAR THE FULL RESPONSIBILITY AND ALL THE CONSEQUENCES AS AN AGGRESSOR. AS FOR COMMUNIST NORTH VIETNAM, IT HAS BEEN A LIBERATOR, WHICH AUTOMATICALLY GIVES IT THE RIGHT TO SEND NORTH VIETNAMESE TROOPS TO THE SOUTH AND TO DECIDE ON ANY POLITICAL SETTLEMENT IN THE SOUTH UNDER THE PRINCIPLE THAT VIETNAM MUST BE ONE AND BELONGS TO COMMUNIST NORTH

FIRST, THE BASIC PROVISION OF THE 1954 GENEVA AGREEMENT ON THE CLEAR DEMARCATION BETWEEN THE SOUTH AND THE MORTH, INCLUDING RECOGNITION OF THE DMZ ACROSS THE 17TH PARALLEL, MUST BE CONFIRMED AND RESPECTED. BOTH PARTS MUST RESPECT EACH OTHER IN ALL RESPECTS, FROM TERRITORY TO SOVEREIGNTY AND FROM MILITARY TO POLITICAL MATTERS. THAT IS TO SAY THAT ONE PART MUST NOT LAUNCH ARMED OR POLITICAL AGGRESSION AGAINST THE OTHER, OR INTERFERE IN THE OTHER'S INTERNAL AFFAIRS TO DISRUPT THEM.

SECOND, ALL NORTH VIETNAMESE TROOPS MUST BE WITHDRAWN TO THE NORTH BECAUSE THEY ARE AGGRESSOR TROOPS COMING FROM OUTSIDE. IT IS UNREASONABLE THAT ONLY U.S. AND OTHER ALLIED TROOPS WHO CAME LATER TO AID US, AT OUR REQUEST, SHOULD HAVE TO WITHDRAW FROM SOUTH VIETNAM FIRST WHILE NORTH VIETNAMESE TROOPS, WHO ARE BOTH FOREIGN AND AGGRESSOR TROOPS, SHOULD HAVE THE RIGHT TO REMAIN.

BOTH SIDES WILL RETURN ALL CAPTURED AND DETAINED PERSONS SIMULTAMEOUSLY WITH U.S. TROOPS PULLOUT. 9240 cate THE COMMUNISTS STILL ADVOCE A GENERAL ELECTION AND THE ESTABLISHMENT OF AN ADMINISTRATIVE STRUCTURE (COW CAAUS CHINHS QUYEENG) CALLED THE NATIONAL COUNCIL FOR NATIONAL RECONCILIATION AND CONCORD CHGIJ DQOONGF QUOOCS GIA HOAF CIAIR VAF HOAF HOWPJ DAAN TOOOJ) CONSISTING OF THREE EQUAL ELEMENTS. ALSO INCLUDED IN THE PROBLEMS TO BE DISCUSSED BY BOTH SIDES IN SOUTH VIETNAM IS THE PROBLEM CONCERNING MEASURES TO DECREASE AND DEMOBILIZE THE STRENGTH OF BOTH SIDES. ARMED FORCES. BOTH SIDES IN SOUTH VIETNAM WILL SIGH AN AGREEMENT ON THE INTERNAL AFFAIRS OF THE SOUTH, AS SOON AS POSSIBLE, AND WILL TRY THEIR BEST TO CARRY THIS OUT WITHIN 3 MONTHS AFTER THE CEASE-FIRE GOES INTO EFFECT.

THE COMMUNISTS ALSO CLAIM THAT THERE ARE ONLY THREE INDOCHINESE COUNTRIES, WHEN DEALING WITH PROBLEMS CONCERNING CAMBODIA AND LAOS, AND THAT THE UNITED STATES WILL CONTRIBUTE TO HEALING THE WAR WOUNDS AND BUILDING THE DRV AND THE WHOLE OF INDOCHINA AFTER THE WAR ENDS.

CTEXT) IN SUM, ALL OF THE POINTS SET FORTH IN THE ANNOUNCED AGREEMENT ARE NO DIFFERENT FROM THOSE CONTAINED IN THE PEACE SOLUTION PROPOSED BY THE COMMUNISTS ON 11 SEPTEMBER.

I WOULD LIKE TO INSERT MY VIEWS ON THE IMPORTANT

KEY POINTS WHICH THE COMMUNISTS STILL MAINTAIN IN THEIR

OLD STAND. THEY DEMAND THAT THE UNITED STATES RESPECT THE

INDEPENDENCE AND TERRITORIAL INTEGRITY OF VIETNAM, HINTING

THAT THIS VIETNAM, STRETCHING FROM NORTH TO SOUTH, IS ONE

AND BELONGS TO NORTH VIETNAM. THE UNITED STATES WILL DISCONTINUE

ITS MILITARY INVOLVEMENT, MEANING THAT IT WILL NEITHER INTERVENE

IN NOR GRANT ANY FORM OF AID TO THE SOUTH.

REGARDING AN INTERNAL POLITICAL SQLUTION, THE COMMUNISTS
STILL MAINTAIN THE ADMINISTRATIVE STRUCTURE CALLED THE
NATIONAL COUNCIL OF NATIONAL RECONCILIATION AND CONCORD.
THE WORD "NATIONAL" APPEARS JUST BEFORE "COUNCIL," MEANING THAT

EXERT ITS INFLUENCE OVER THE TWO EXISTING GOVERNMENTS IN THE
SOUTH. THIS COUNCIL, HAVING THREE EQUAL SEGMENTS WITH THE
SAME NUMBER OF PERSONNEL, WILL SUPERVISE THE TWO EXISTING
GOVERNMENTS AND ORGANIZE A GENERAL ELECTION. THIS MEANS THAT
A NEW CONSTITUTIONAL NATIONAL ASSEMBLY WILL BE ELECTED AND
THERE WILL BE A NEW CONSTITUTION AND A NEW SYSTEM (COW CHEES)

THE COMMUNISTS ALSO STATED THAT THE TWO SIDES IN THE SOUTH WOULD DISCUSS (HIEEPJ THUWOWNG) THE FORMATION OF COUNCILS AT A LOWER LEVEL, FROM THE CENTRAL TO THE VILLAGE AND HAMLET LEVELS. THE COMMUNISTS RESORTED TO A VERY CRAFTY USE OF TERMS WHEN THEY STATED THAT THE PROBLEM CONCERNING THE VIETNAMESE ARMED FORCES IN THE SOUTH WOULD BE SETTLED BY THE TWO SIDES IN THE SOUTH. THIS MEANS THAT THEY WANT NORTH VIETNAMESE FORCES TO BE CONSIDERED AS FORCES OF THE LIBERATION FRONT.

THUS, IF WE WANT TO SETTLE THE PROBLEM CONCERNING WORTH

VIETNAMES FORCES AS WELL AS ITREPATION FORCES WE MUST TALK NO Objection to Declassification in Full 2010/08/06 LOC-HAK-248-1-21-2 WITH THE LIBERATION FRONT, WHILE THE NORTH VIETNAMESE FORCES WILL BE CONSIDERED AS NATURALLY BELONGING TO THE LIBERATION FRONT AND ITS GOVERNMENT. THUS, IN THEIR 11 SEPTEMBER SOLUTION THE COMMUNISTS CONSIDER THAT THE POLITICAL REALITY IN THE SOUTH INVOLVES TWO GOVERNMENTS AND TWO ARMIES, WITH SOME HUNDREDS OF THOUSANDS OF NORTH VIETNAMESE TROOPS BEING CONSIDERED AS SOUTHERN LIBERATION TROOPS.

AFTER THE COMMUNISTS ANNOUNCED THE AGREEMENT, WE SAW THAT THEY STILL MAINTAINED THEIR ILLOGICAL CONDITIONS. THE TWO MOST FUNDAMENTAL CONDITIONS CONCERNING THE SURVIVAL OF THE SOUTH ARE: FIRST, THE FORMATION OF A DISGUISED COALITION GOVERNMENT THROUGH AN ILLOGICAL FORMULA OF THREE EQUAL SEGMENTS--FROM THE SUPERSTRUCTURE TO THE VILLAGE AND HAMLET LEVELS--TO ORGANIZE A GENERAL ELECTION; AND SECOND, THE NORTH VIETNAMESE FORCES' FAILURE TO WITHDRAW TO THE NORTH.

WITH REGARD TO THESE POINTS, I WOULD LIKE TO REPORT TO THE CONGRESS ON THE RVW GOVERNMENT'S PROPOSALS AND VIEWPOINTS.

REGARDING THE PROBLEM OF THE WITHDRAWAL OF NORTH
VIETNAMESE TROOPS TO THE NORTH, WE HAVE PROPOSED THAT ALL
NORTH VIETNAMESE TROOPS IN THE SOUTH MUST WITHDRAW TO THE NORTH
AT THE SAME TIME OTHER FOREIGN FORCES ARE WITHDRAWN. AFTERWARD,
THE RVN GOVERNMENT WILL ACCEPT THE SAME REDUCTION OF NUMERICAL
STRENGTH OF THE ARVN TO SHOW ITS PEACEFUL GOOD WILL,
CONSIDERING THAT THE REQUIREMENTS OF WAR NO LONGER EXISTS.
HOWEVER, NORTH VIETNAM HAS REJECTED THIS PROPOSAL.

VIETNAM, LET ME TELL YOU OF OUR OLD AND NEW PROPOSALS.

WE HAVE PROPOSED THIS FORMULA: TO DECIDE THE COMPOSITION OF THE NATIONAL RECONCILIATION AND NATIONAL CONCORD COMMITTEE (UYR BAN) WHICH WILL BE IN CHARGE OF ORGANIZING THE ELECTIONS OF THE NEW PRESIDENT AND VICE PRESIDENT OF THE REPUBLIC, AND TO MAKE EVERYONE REALIZE THE PERCENTAGE OF THE SOUTH VIETNAMESE PEOPLE WHO FOLLOW THE COMMUNISTS AND THE PERCENTAGE OF THOSE WHO FOLLOW THE NATIONAL CAUSE, WE HAVE PROPOSED THAT A POPULAR REFERENDUM BE ORGANIZED AND SUPERVISED BY THE UNITED NATIONS. WE WILL RELY ON THE RESULTS OF THIS COMPOSITION OF THE COMMITTEE (UYR VAN) IN CHARGE OF ORGANIZING THE ELECTIONS OF THE NEW PRESIDENT AND VICE PRESIDENT OF THE REPUBLIC.

AFTER THE ELECTION, THE NEW PRESIDENT OF THE REPUBLIC WILL FORM A SO-CALLED NATIONAL COALITION GOVERNMENT, THE MEMBERS OF WHICH WILL BE DETERMINED BY THE NUMBER OF VOTES GAINED BY THE CANDIDATES TO THE PRESIDENTIAL ELECTIONS. THUS THE MAN WHO OBTAINS THE LARGEST NUMBER OF POPULAR VOES WILL BE THE PRESIDENT OF THE REPUBLIC AND WILL RUN THE GOVERNMENT. THEN, THE POLITICAL PARTIES AND POPULAR ORGANIZATIONS WILL SEND THEIR MEN TO PARTICIPATE IN THE GOVERNMENT IN ACCORDANCE WITH THE PERCENTAGE OF VOTES OBTAINED BY THEIR PRESIDENTIAL CANDIDATES.

OF SOUTH VIETNAM BE SOLVED BY THE TWO OPPOSITE SIDES;
THAT IS, THE RVM GOVERNMENT AND THE NFLSV. ONLY THE
TWO OPPOSITE SIDES WILL SEND THEIR REPRESENTATIVES TO FORM
