THE STATE DEPARTMENT HAS RECEIVED THE 19 JULY NOTE OF THE DRV MINISTRY OF FOREIGN AFFAIRS.

THE UNITED STATES IS OF THE SAME OPINION THAT THE DISCUSSIONS BETWEEN THE REPRESENTATIVES OF OUR TWO GOVERNMENTS IN PARIS ARE TO BE APPROPRIATE AND USEFUL. THE UNITED STATES IS EXPECTING TO BE REPRESENTED AT THIS MEETING BY THE DEPUTY CHIEF OF MISSION OF THE U.S. EMBASSY IN PARIS AND SUGGESTS THAT THE MEETING TAKE PLACE AT THE U.S. EMBASSY OR ANOTHER LOCALITY AGREED UPON BY THE TWO PARTIES.

THE DRV FOREIGN MINISTRY ACKNOWLEDGES RECEPTION OF THE 19 JULY 1976 NOTE FROM THE U.S. DEPARTMENT OF STATE.

THE DRV GOVERNMENT ON MANY OCCASIONS, CLEARLY UNDERLINED ITS POINT OF VIEW CONCERNING THE PARIS AGREEMENT AND THE NORMALIZATION OF RELATIONS BETWEEN VIETNAM AND THE UNITED STATES. THIS STAND WAS ALSO AFFIRMED IN ITS 19 JUNE 1976 NOTE ADDRESSED TO THE UNITED STATES.

AS FAR AS THE MEETING OF THE REPRESENTATIVES OF THE TWO PARTIES IN PARIS IS CONCERNED, THE SRV SUGGESTS THE FOLLOWING:

THE SRV REPRESENTATIVE WILL BE THE COUNSELLOR OF THE EMBASSY OF VIETNAM IN PARIS.

THE MEETING WILL TAKE PLACE OUTSIDE OF THE EMBASSY OF EACH PARTY; THE TWO PARTIES WILL TAKE TURNS IN MAKING ARRANGEMENTS ON THIS SUBJECT.

IF THE AMERICAN OFFICERS OF THE TWO PARTIES APPROVES THE SUGGESTION, THE LIAISON OFFICERS WILL PROCEED TO AN EXCHANGE OF VIEWS ON THE DATE AND PLACE OF THE FIRST MEETING.
