I. DINITZ CALLED ME THIS AFTERNOON WITH SOME OF THE DETAILS OF THE AGREEMENT REACHED BETWEEN THE ISRAELIS AND EGYPTIANS TODAY WHICH I WOULD LIKE TO PASS YOU:

- (1) ALL POWS, INCLUDING WOUNDED, WILL BE EXCHANGED BEGINNING 8:00 A.M. TOMORROW MORNING BY RED CROSS PLANES. THE EXCHANGE WILL INCLUDE WOUNDED FROM THE CITY OF SUEZ AND THE THIRD ARMY AND WILL BE COMPLETED WITHIN SEVEN DAYS.
- (2) CONVOYS OF 25 TRUCKS EACH WILL BE DISPATCHED TO SUEZ AND TO THE THIRD ARMY TOMORROW MORNING. IT HAS BEEN AGREED THAT THE TOTAL TONNAGE PER DAY OF RESUPPLY WILL BE 250 TONS.
- (3) UN CHECKPOINTS WILL BE SET UP AT KM 101, KM 119, AT THE SUEZ CITY RAILROAD STATION, AND AT THE BANK OF THE CANAL. INSPECTION WILL TAKE PLACE AS IN THE AGREEMENT FOR THE THIRD ARMY AND NEAR THE RAILROAD STATION AT SUEZ, WHERE ISRAELI OBSERVERS WILL BE PERMITTED, BUT NOT IN UNIFORM. THE ISRAELIS ARE WILLING TO PERMIT RAILROAD RESUPPLY TO SUEZ CITY.
- (4) SEARCHING PARTIES WILL BE ALLOWED TO BEGIN A SEARCH FOR THE DEAD EAST OF THE CANAL.
