1. I HAVE JUST SEEN EILTS' REPORT ON HIS CONVERSATION WITH FAHMI, AND SISCO'S PROPOSALS (TOSEC 10) ON HOW TO RESPOND.
2. YOU SHOULD SEE DOBRYNIN SOONEST AND TELL HIM OF FAHMI'S LATEST DEMANDS. TELL HIM, AS WELL, THAT I AM PREPARED TO INDULGE FAHMI ON THE UN AUSPICES ISSUE, BUT THAT THIS IS OUR FINAL COMPROMISE. WE CANNOT MOVE ON THE "TIMING" PROBLEM BECAUSE IT WILL LEAD TO AN EXPLOSION IN ISRAEL AND A REFUSAL TO ATTEND ANY CONFERENCE, AND YOU SHOULD TELL HIM SO. NOW IT IS TIME FOR THE SOVIETS TO USE THEIR INFLUENCE ON SADAT AND THE SYRIANS. IF THEY WILL NOT, OR CANNOT, MOVE HIM THERE CAN BE NO CONFERENCE. YOU SHOULD ALSO REMIND DOBRYNIN OF OUR UNDERSTANDING WITH BREZHNEV REGARDING PRISONERS HELD BY SYRIA.
3. YOU SHOULD SEE DINITZ AND BRING HIM UP-TO-DATE ON FAHMI'S DEMANDS. TELL HIM WHAT YOU HAVE SAID TO DOBRYNIN ABOUT "TIMING," BUT DO NOT SAY ANYTHING ABOUT MY WILLINGNESS TO MOVE ON UN AUSPICES.
4. REPORT TO ME SOONEST ON BOTH CONVERSATIONS.
